I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Amendment No. 1 to the Consulting/Professional Services System-Wide Force Main Evaluation (Contract) with CDM Smith Inc., (CDM) providing for the renewal of the contract for one (1) year.

Summary: On February 9, 2021, the Board of County Commissioners (BCC) approved the Palm Beach County Water Utilities Department (PBCWUD) Contract (R2021-0240) with CDM, which provides consulting/professional engineering, surveying, field testing, and condition assessment of wastewater force main pipes. Amendment No. 1 renews the contract for another year.

This Contract was procured under the requirements of the Equal Business Opportunity Ordinance. On March 4, 2020, the Goal Setting Committee applied an Affirmative Procurement Initiative (API) of a mandatory 20% Small Business Enterprise (SBE) subcontracting goal and an evaluation preference for up to 15 points based upon the relative level of dollar participation by certified African American owned firms. CDM has met the established API. The Contract provides for 22% SBE participation, which includes 22% MBE participation, 14% MBE (B) and 8% MBE (A).

Article 2 of the Contract provides for a term of three (3) years with two one (1) year renewal options. Amendment No. 1 to the Contract provides for the first of the optional renewals. While CDM is headquartered in Boston, Massachusetts, they maintain an office in Palm Beach County from which the majority of the work under this Contract will be performed. The Contract is included in the PBCWUD FY24 Budget. (PBCWUD Project No. 20-015) <u>Countywide</u> (MWJ)

Background and Justification: PBCWUD owns, operates and maintains over 600 miles of wastewater force main pipes ranging in size from 4 inches to 54 inches with various pipe material throughout its service area. The work to be completed under this Contract will include an update of a previously completed risk assessment. The existing wastewater force main pipeline conditions will be verified through physical inspections of pipeline segments identified with the highest risk which will help to determine the need and timing for replacement. The development of an evaluation framework to dynamically prioritize its pipeline assets will allow PBCWUD to maintain its fiscal responsibility as it transitions to a sustainable utility. The actual field inspection results will be correlated with the previously completed risk assessment to support development of specific recommendations for maintenance and repairs.

Contract are hereby confirmed and remain in full force and effect.


