Additionally, the BCC ratifies the Palm Beach County League of Cities municipal representatives and alternates. The only restriction on both the members and alternates is that they are elected officials. The TCRPC is charged with discussion of local government comprehensive plans, developments of regional impact, and other regional planning activities, and has requested the BCC ratify the municipal representatives appointed by the League.
