I. EXECUTIVE BRIEF

Title: Emergency Medical Services Secondary Certificate of Public Convenience and Necessity (COPCN) Update

Summary: The purpose of this workshop is to provide a three-year update to the Board of County Commissioners (BCC) on the performance of the current Secondary COPCN holders which are Atlantic/Palm Beach Ambulance, Inc. d/b/a American Medical Response (AMR), Medics Ambulance Service, Inc. (Medics), and Health Care District of Palm Beach County (HCDPBC). On July 1, 2021, these companies were licensed to provide secondary Advanced Life Support (ALS) transport services and ALS/Basic Life Support (BLS) Inter-facility transport services in Palm Beach County until June 30, 2027. At the June 15, 2021 BCC meeting, the BCC requested that within three years from the COPCN start date of July 1, 2021, a decision to whether there was a public safety need for additional Secondary COPCN providers in Palm Beach County would be reevaluated. In order to ensure that Palm Beach County is providing its residents with quality EMS services, determination must be made on whether the EMS Ordinance's six (6) year licensing timeline needs to amended/revised to allow for additional Secondary ALS Transport Services and ALS/BLS Inter-Facility Transport Services. Countywide (SB)

Background and Policy Issues: In accordance with Palm Beach County Code, Chapter 13, Article II, EMS Ordinance, any agency desiring to provide secondary ALS transport services and ALS/ BLS Inter-facility transport services must submit an application to the County and meet the requirements for issuance of a COPCN. Applications for secondary provider COPCNs are issued every six (6) years for a six-year term. Since 2000, AMR and Medics (owned by the same parent company) have been the recipient of the secondary provider COPCNs in Palm Beach County, which expire June 30, 2027. For the current period, seven (7) applications for secondary provider COPCNs were received. The EMS Ordinance Administrator's responsibilities include reviewing the applications for compliance with the EMS Ordinance application requirements, consideration of the need for the proposed service in the requested area, and preparing a report with recommendations for the EMS Advisory Council (Council).

Background and Policy Issues: Consideration of the need for the proposed services was primarily based on data collected from the current service providers for a 2-year period. survey information, and input and data collected from a number of local hospitals who are the primary users of the service. The initial Administrator's report included the following: 1) Approval of secondary provider COPCNs to AMR, Medics, and the HCDPBC (with conditions); and 2) Denial of secondary provider COPCNs to All County Ambulance. Century Ambulance Service, Inc., National Health Transport, Inc., and Rapid Response Medical Transportation LLC for not finding convincing evidence there was a need for the proposed service offered. Furthermore, National Health Transport, Inc. and Rapid Response Medical Transportation, LLC failed to meet the EMS Ordinance application requirements which also supports denial of their applications. The Administrator's report with the recommendations on all applications was subsequently submitted to the Council for their review and recommendations. On May 13, 2021, the Council reviewed the Administrator's report on all seven (7) applications and heard oral presentations from each company. Out of the 17 Council members voting, the Council voted to recommend approval of four (4) secondary provider COPCN applications to the BCC with the votes as follows:

2. Medics (17 - yes, 0 - no)
3. HCDPBC (17 - yes, 0 - no)
4. All County Ambulance (10 - yes, 7 - no)

The Council voted to recommend denial of three (3) secondary provider COPCN applications to the BCC with the votes as follows:

At the EMS Council meeting, several Council members from the hospitals expressed concerns regarding delayed response times from the current providers. Therefore, the Administrator held discussions with the hospital Chief Executive Officers (CEO) for additional input and to gain a better understanding of the issues as well as conducted further research with the hospitals. Based on the additional data gathered along with supporting arguments by the hospital CEO's on the need for additional providers, the Administrator supported the Council's recommendation of approving the (4) secondary provider COPCN applications and denying (3) secondary provider COPCN applications as referenced in the motion and title of this agenda item.

The BCC meeting on June 15, 2021 approved the following Secondary Service Provider Emergency Medical Service (EMS) COPCN for the period July 1, 2021 through June 30, 2027:

- 1. American Medical Response (AMR)
- 2. Medics Ambulance Service, Inc. (Medics)
- 3. Health Care District of Palm Beach County (HCDPBC) (with conditions)

The BCC denied the following Secondary Service Provider EMS COPCN for the period July 1, 2021 through June 30, 2027:

- 1. All County Ambulance
- 2. Century Ambulance Service, Inc.
- 3. National Health Transport, Inc.
- 4. Rapid Response Medical Transportation, LLC

Secondary COPCNs Approved by BCC

On June 15, 2021, the BCC approved the following Secondary Service Provider Emergency Medical Services Certificate of Public Convenience and Necessity for the period July 1, 2021 through June 30, 2027:

- 1) American Medical Response (AMR)
 - Service area to include all of Palm Beach County.
- 2) Medics Ambulance Service, Inc.
 - Service area to include all of Palm Beach County.
- 3) Health Care District of Palm Beach County (with conditions)
 - Service area is limited to HCDPBC patients needing transports from Lakeside Medical Center to other HCDPBC facilities and specialized treatment centers and HCDPBC patients needing transports to and from the JFK North Addiction Stabilization Unit within Palm Beach County.



Secondary COPCNs Denied by BCC

On June 15, 2021, the BCC Denied the following Secondary Service Provider Emergency Medical Services Certificate of Public Convenience and Necessity for the period July 1, 2021 through June 30, 2027:

- 1. MCT Express, Inc. d/b/a All County Ambulance
- 2. Century Ambulance Service, Inc.
- 3. National Health Transport, Inc.
- 4. Rapid Response Medical Transportation, LLC



June 15, 2021 BCC Direction

- Capture better data from hospitals. All commissioners wanted to see a better data collection process for hospitals before willing to embrace adding more COPCN holders.
- BCC has the discretion to come back within 3 years to re-evaluate the EMS public safety needs of the county based on hospital concerns and population growth.
- Any changes made to COPCN process would require an ordinance revision.



Additional Efforts

- 1) Conducted a <u>follow up survey</u> with 16 Hospitals and 288 Assisted Living Facilities and Nursing Homes
- Met with all hospital CEOs to determine whether needs were being met.
- 3) Requested data again from all hospitals and providers for the period January 2023 through December 2023 for inter-facility transports. Received the following:
 - a) Palms West
 - b) JFK Medical Center
 - c) JFK Medical Center North
- 4) Developed an <u>Ordinance Revision Subcommittee</u> of the EMS Advisory Council.




Survey to COPCN Users


- Survey sent to 288 Assisted Living Facilities and Nursing Homes and 16 Hospitals

Survey Findings - Do you want more providers?









Survey Findings – Are needs being met?








Survey Findings – Do you want to replace current provider?







Hospital Feedback

- Expressed concerns on delayed response times and the need for more providers.
- Additional providers would drive competition.
- Needing more than 1 ambulance provider is like needing more than 1 hospital.
- With a growing population and healthcare system demands, an additional provider is needed.
- Current providers are not able to meet the demands of the initial requested time of arrival and have no other choice but to agree to an Estimated Time of Arrival provided.
- Having only 1 provider does not allow options for other availability.
- Constant delays effect hospital throughput.


Monthly Response Time Requirements

- 1. Request for transport by a Fire Rescue Agency:
 - a) Average of 10 minutes.
- Priority 1 Inter-facility Transports to higher level of care -Stroke, trauma, etc.
 - a) Average of 10 minutes.
- Urgent Transports, not prescheduled:
 - a) Within 30 minutes of agreed upon time, 90% of the time.
- 4. Pre-scheduled transports
 - a) Within 15 minutes of agreed upon time, 90% of the time.
- 5. Patient ready for transport when unit arrives:
 - a) Facility must have patient ready within 30 minutes of units arrival.





6.1 - Request by a Fire Rescue Agency for Transport of emergency medical patients.













6.2 Urgent transports, not prescheduled









6.3 - Routine scheduled transports







Facility Patient Readiness

Ordinance Requirement: Patient must be ready within 30 Min of arrival of transport unit











PBC Interfacility Trauma Transfers (IFT)


Transfers from Non-Trauma hospitals to Trauma Centers (TC)



Ordinance Requirement: Average Response Time - 10 Min





Ordinance Revision Subcommittee Considerations

- Update outdated terminology
- Update timelines associated with application period to be more consistent with staff's review process.
- Clarify gaps where its silent on some issues, such as interfacility transports vs. transport to home, subscription services, other services that can be offered but not, due to a lack of clarity in ordinance.
- Clean up entire document to make it more user friendly.
- Review response time levels to ensure validity and rationality.

Current Secondary COPCN Application Process

- Applications publically noticed between 90 120 days of the expiration date of the existing COPCNs.
- Applications accepted between 45 90 days of the expiration date of the existing COPCNs.
- 3. Application includes 11 requirements pursuant to the EMS Ordinance. Additional requests for information may be requested at the discretion of the Administrator.
- 4. Administrator reviews applications for compliance and consideration of the need, prepares and presents a report with recommendations to EMS Advisory Council for review and recommendation.
- EMS Advisory Council meeting is scheduled and applicants and affected COPCN holders are notified and may be heard concerning the applications.
- 6. EMS Advisory Council makes recommendation on the applications to be provided to Board of County Commissioners (BCC).
- 7. Public hearing is scheduled with BCC to consider Administrator's report and the recommendation of the EMS Council.



Application Criteria & EMS Ordinance Requirements

- 1. Statement of public need and services to be covered.
- 2. Copy of current State Emergency Medical Services (EMS) license(s) and/or current COPCN, if any.
- 3. Agency vehicles
- 4. Personnel roster.
- 5. Certificate of Insurance
- Florida licensed physician Medical Director (MD) Executed agreement.
- 7. MD letter stating agency adopted min. standard, pre-hospital treatment/transport protocols.
- 8. Letter from MD stating agency has adopted the countywide Trauma Transport Protocols.
- 9. Proposed rate structure.
- 10. Audited Financial Statements
- 11. Summary history of applicant's ALS or BLS emergency services performance record.
- 12. Disclosure of litigation involving patient care.
- 13. Federal/state/local agency vehicle & staff inspections past 6 years.
- 14. Formal quality assurance system.
- 15. Emergency Medical Dispatch (EMD) program or an agreement for appropriated EMS service.
- 16. MOU with Palm Beach County for radio communications.
- 17. Letter from CEO or Fire Chief that agency met federal/state/local requirements on delivery of EMS.
- 18. Management Plan: a) Employee and Driver training programs, b) Complaint handing system, c) System for handling accidents and/or injuries, d) Vehicle maintenance system.
- 19. Minimum of three (3) letters of reference (to include one hospital) .
- 20. Benchmark Response Times. Provide data for previous six months of transports (Form A).
- 21. Non-refundable application Fee

BCC Direction Needed

- Is there a desire to amend the EMS Ordinance to establish criteria to allow the County to open up an additional Secondary Service Provider COPCN application period, to add additional providers if there is a public safety need, prior to the end of the current 6 year timeline outlined in the ordinance?
- If not, the 6 year COPCN term for the current Secondary Service Providers (AMR, Medics, and HCD) ends June 30, 2027, at which time additional providers can be considered.
