I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Amendment No. 5 (Amendment) to the Contract for Consulting/Professional Services (Agreement) with Ricondo & Associates, Inc. (Ricondo) in the amount of \$813,898 for the provision of professional consulting services for the Department of Airports (Department).

Summary: The Agreement with Ricondo was approved on August 23, 2022 (R2022-0888) in the amount of \$2,021,165 for the provision of professional consulting services for the Department. Amendment No. 1 through Amendment No. 4 increased the contract amount by \$2,580,702.03 and provided for various services, including, but not limited to, the Palm Beach County Park Airport (LNA) Safety Assessment, LNA Master Plan Update, Palm Beach International Airport (PBI) Cyber Security Implementation Support, 2024 Bond Feasibility Report, and PBI Consolidated Rental Car Facility (CONRAC) Advanced Planning, and exercised the first one (1) year renewal option. A detailed contract history is included in Attachment 1. This Amendment will increase the contract amount by \$813,898, resulting in a total contract amount of \$5,415,765.03. This Amendment includes the following Consultant Services Authorizations (CSAs): Task I Services - PBI Concourse B Construction - Gate Optimization Analysis, PBI 2025 Cyber Security Program Support Services, North Palm Beach County General Aviation Airport (F45) Conceptual Fixed Base Operator (FBO) Site Plan, Triennial Review Appraisals, and LNA Aviation Activity Forecast, and Task III Miscellaneous Services. Task III Miscellaneous Services are services that are not defined at the time of approval of an amendment to the Agreement and are approved pursuant to delegated authority in accordance with PPM CW-F-050 by way of a separate task authorization. Ricondo is based in Chicago, Illinois; however, the majority of the work will be managed through its Miami, Florida The Agreement was presented to the Goal Setting Committee (Committee) on office. September 1, 2021, and the Committee established an Affirmative Procurement Initiative (API) of a mandatory 10% Small Business Enterprise (SBE) subcontracting goal. Ricondo committed to 11% Small/Minority/Women Business Enterprise (S/M/W/BE) participation. The proposed S/M/WBE participation for this Amendment is 0%. To date, the overall participation achieved on this Agreement, including this Amendment, is 10%, which includes 3% WBE and 2% MBE (African American) participation. Countywide (AH)

Background and Justification: The Department requires additional professional consulting services to comply with the Transportation Security Administration's Emergency Amendment 23-01, which requires all Category I airports to develop and maintain a cybersecurity implementation plan. Triennial review appraisals are needed to assess the fair market rental value of properties at the County's four (4) airports. During the final phase of the Concourse B expansion project, airline gates will be temporarily removed to accommodate construction activities. A gate optimization analysis is needed to ensure proper coordination of gate usage by the airlines operating at PBI throughout the Concourse B expansion project. Based on increased demand for aviation facilities, conceptual site plans are needed to plan for the development of additional FBO facilities at F45. Due to recent forecast methodology changes by the Federal Aviation Administration, the aviation activity forecast must be updated to complete the LNA Master Plan Update.

WHEREAS, on May 16, 2023, the COUNTY entered into an Amendment No. 1 (R2023-0700) with the CONSULTANT for the CONSULTANT to provide additional professional services for the Department of Airports in accordance with Article 26 of the Contract; and

WHEREAS, on January 23, 2024, the COUNTY entered into an Amendment No. 2 (R2024-0045) with the CONSULTANT for the CONSULTANT to provide additional professional services for the Department of Airports in accordance with Article 26 of the Contract; and

WHEREAS, on May 14, 2024, the COUNTY entered into an Amendment No. 3 (R2024-0545) with the CONSULTANT for the CONSULTANT to provide additional professional services for the Department of Airports in accordance with Article 26 of the Contract; and

WHEREAS, on August 20, 2024, the COUNTY entered into an Amendment No. 4 (R2024-0927) with the CONSULTANT for the CONSULTANT to exercise the first one (1) year renewal option for the continuation of services provided by the CONSULTANT under this contract and provide additional professional services for the Department of Airports in accordance with Article 26 of the Contract; and

NOW THEREFORE, in consideration of the mutual covenants herein contained, and such other good and valuable consideration, the receipt of which the parties hereby acknowledge, the following terms and conditions:

1. The Contract is hereby amended to add the Scope of Services and Fees set forth in Exhibit A to this Amendment No. 5. The total amount to be paid by the COUNTY to the CONSULTANT for professional services associated with this Amendment No. 5, including any out-of-pocket expenses, shall not exceed Eight Hundred Thirteen Thousand, Eight Hundred Ninety-Eight Dollars and No Cents (\$813,898.00).

Task I-25-PBI-R-017: Gate Optimization Analysis (Concourse B Construction)

Palm Beach International Airport (PBIA)

Introduction

In March 2025, the Palm Beach County Department of Airports (DOA) will begin the construction of Concourse B Expansion at Palm Beach International Airport (PBI or the Airport). The project will provide the Airport with 2 additional gates and the construction phase will be sequenced to minimize gate closures. To facilitate coordination with the Airlines, the DOA team has requested the assistance of the Ricondo & Associates, Inc. (Ricondo) team to analyze the gate demand throughout the construction period to validate the construction schedule and associated gate closures.

To support these efforts, an allowance account would be established to allow Ricondb to assist the DOA with the review, analyzes and evaluation of the gate demand through Concourse B Expansion construction period, and with the creation of presentation materials summarizing key findings.

Services performed under this Professional Services Authorization would be compensated based on a lump sum basis in accordance with the terms associated with Master Agreement Resolution №umber R2022-0888 (Solicitation DOA 21-11) for Airport Planning Consulting Services between Ricondo and the DOA.

Task and Cost

This scope of services includes Planning Services. Total Lump Sum labor cost of this scope of services is \$45,068.00.

Scope of Services

Task 1: **Gate Optimization Analysis**

In addition to conducting the various technical analyses associated with the following sub-tasks, this task includes the preparation of deliverables requested by the DOA.

Sub-task 1.1 Data Collection

Under this task, Ricondo will coordinate with the DOA to collect the relevant information pertaining to the construction of Concourse B Expansion and the airport 's existing conditions.

Gate Optimization Analysis -**Concourse B Construction**

- Concourse B Expansion Phasing Plates
- Concourse B Expansion Construction Schedule and Associated Gate Closures
- Existing and Future Gate Layout and Airline Allocation
- Latest Passenger Activity Forecast

In addition, Ricondo will obtain daily airline schedules that have been recently published in Cirium Diio Mi for a peak day in March 2025 (Baseline Schedule). All the data collected under this task will inform the analyzes that will be conducted under sub-tasks 1.2 and 1.3.

Sub-task 1.2 Demand Analysis

Ricondo will develop three (3) demand scenarios for relevant construction milestones based on growth assumptions from the latest passenger activity forecast and/or based on recent historical growth. For each demand scenario, Ricondo will prepare daily flight schedules based on the baseline flight schedule (March 2025) modified to reflect the projected future fleet mix; markets served and expected future peaking characteristics. Gating of the developed schedules will be performed under sub-task 1.8.

Sub-task 1.3 Gating Analysis

The flight schedules developed under sub-task 1.2 will form the basis for generating a series of ramp charts. These ramp charts will be derived utilizing CAST software that includes gate allocation capabilities. The resulting ramp charts will highlight gate utilization metrics, gate availability and peak hour gate requirements. Based on the gating results, Ricondo will provide feedback to the DOA on the construction schedule and recommend any changes as needed.

Sub-task 1.4 Deliverables

Ricondo will summarize the analysis results into presentation materials (PowerPoint) to facilitate internal review and discussion with the Airlines. A draft of the PowerPoint presentation will be submitted to the DOA for review and comment. Ricondo will participate in up to two (2) virtual meetings with DOA staff to review and amend the summary PowerPoint presentation.

Task 2: Task Administration

This task includes the preparation of scope, budget, EBO forms and other documents contained in the contract amendment. It also includes preparation of monthly invoices, and status reports.

Task I-25-LNA-R-019: LNA Aviation Activity Forecasts

Palm Beach County Park Airport (LNA)

Introduction

The Palm Beach County Department of Airports (DOA) has requested that the Ricondo & Associates, Inc. (Ricondo) Team prepare aviation activity forecasts for Palm Beach County Park Airport (LNA), using Fiscal Year (FY) 2024, which ends September 30, as the base year and forecast period of FY 2025 through FY 2044. The forecasts will be prepared for Federal Aviation Administration (FAA) review and approval and form the basis for the ongoing Master Plan Update for LNA.

Services performed under this Professional Services Authorization would be compensated based on a lump sum basis in accordance with the terms associated with Master Agreement Resolution Number R2022-0888 (Solicitation DOA 21-11) for Airport Planning Consulting Services between Ricondo and the DOA.

Task and Cost

This scope of services includes Planning Services. Total Lump Sum labor cost of this scope of services is \$44,948.00.

Scope of Services

Task 1:Aviation Activity Forecasts

The primary task involves conducting an analysis of historical aviation activity and a developing forecast of future aviation activity, including annual aircraft operations, peaking characteristics, fleet mix, based aircraft, and critical aircraft. The development of the Aviation Activity Forecasts includes the following sub-tasks:

Sub-task 1.1 Data Collection

Ricondo will collect historical aviation activity data, including from the Palm County Department of Aviation (DOA), the Airport Noise and Operations Management System (ANOMS), and the FAA's Traffic Flow Management System Counts (TFMSC) dataset.

Sub-task 1.2 Analysis of Historical Activity

Ricondo will present and analyze historical activity, including historical total operations, the breakdown of operations by category (general aviation, air taxi, military, local, itinerant, etc.) and aircraft fleet mix, peaking characteristics, and based aircraft.

Sub-task 1.3 Factors Affecting Aviation Activity

Ricondo will develop an analysis of local, regional, and national factors that influence activity at general aviation (GA) airports and evaluate the relevance of these factors to activity at LNA. These factors include socioeconomic factors, industry aircraft market trends, technological shifts, operational restrictions, and the role of LNA within the DOA system of airports as well as within the broader context of the South Florida region.

Sub-task 1.4 Baseline Forecast of Aviation Activity:

Ricondo will develop an analysis of future aviation activity, using FY 2024, ending September 30, as the base year and forecast period of FY 2025 through FY 2044. The forecast will consider recent trends at LNA, national growth rates identified in the most recent FAA Aerospace Forecasts, and LNA's share of local, regional, and national share of GA activity. The forecasts will present future annual operations, the breakdown of operations by category and aircraft fleet mix, peaking characteristics, based aircraft, critical aircraft.

Sub-task 1.5 Forecast Comparison

Forecast Comparison: Ricondo will present a comparison of the aviation activity forecast to the latest FAA Terminal Area Forecast (TAF) for LNA.

Task 2: Meetings

Meetings associated with the development of the aviation activity forecasts will consist of virtual meetings with both the DOA and FAA. These meetings will be performed in accordance with the following sub-tasks:

Sub-task 2.1 DOA Consultation Meetings

Ricondo will prepare for and attend up to three (3) coordination meetings with DOA staff to review draft materials and prepare for future meetings with FAA staff. Each meeting will be conducted virtually with up to three (3) staff from the Ricondo Team.

Sub-task 2.1 FAA Forecast Review Meetings

Ricondo will prepare for and attend up to two (2) coordination meetings with FAA staff to review the draft submittals of the aviation activity forecast. Up to three DOA coordination meetings will be performed. Each meeting will be conducted virtually with up to three (3) staff from the Ricondo Team.

Task 3: Deliverables

The deliverables for this effort will include the development of a draft and final forecast chapter to be included in the LNA Airport Master Plan Update. The forecast chapter will include a summary of historical data, analysis of recent trends and factors affecting aviation activity, the assumptions and methodology used to develop the activity forecasts, forecast results, and comparison to the TAF.

Sub-task 3.1 Draft Forecast Chapter

Up to two draft reports will be prepared. The first (preliminary) draft report will be submitted to the DOA for review and comment. Upon receiving comments from the DOA, a second (revised) draft report will be prepared for submission to the FAA for review and comment. Both draft reports will be submitted in PDF format.

Sub-task 3.1 Final Forecast Chapter

Upon receiving comments from the FAA, a third (final) draft report will be prepared for submission to the FAA for review and comment. The final chapter will be submitted in both electronic and hardcopy format. The printing costs associated with the Final Forecast chapter will be funded separately through Task I-23-LNA-R-011, LNA Master Plan.

Task 4: Task Administration

This task includes the preparation of scope, budget, EBO forms and other documents contained in the contract amendment. It also includes preparation of monthly invoices, and status reports.

The appraisal will be reviewed by PBCDOA staff and it is understood the appraisal fee will be paid upon completion of the appraisal review by PBCDOA staff, subject to the Ricondo payment process.

Sub-task 1.4 Rates and Charges

The Palm Beach County Department of Airports (PBCDOA) requires rates and charges consulting regarding general aviation fuel flowage and landing fees at their airports (i.e., PBI, PHK, LNA, F45) and subject to Federal Aviation Administration (FAA) grant assurances.

The DOA desires to establish and charge fair and reasonable fees to airport users including general aviation fuel flowage and general aviation landing fees. The purpose of the analyses is to provide a basis for establishing fees based on similar fees charged at competitive airport in Florida as of a current date of valuation. The intended use of the analyses is to assist the DOA in establishing user fees. The intended users of the analyses are the DOA and the FAA.

The appraiser is state-certified by Florida and holds the MAI designation of the Appraisal Institute and has significant experience in estimating airport rents, fees and charges in Florida. The deliverables include up to four (4) signed copies of the analyses, as well as PDF versions of the reports and will be delivered within the schedule provided.

The DOA will make available, to the extent that such information exists, relevant information concerning the existing users fees at their airports. The analyses will be reviewed by DOA staff and it is understood the

consulting fee will be paid within 30 days of the completion of the review by DOA staff, subject to the DOA payment process.

Task 2:Miscellaneous Appraisal Services

The Palm Beach County Department of Airports (DOA) has requested the services of the Ricondo & Associates Team (Ricondo) to provide appraisal services for various parcels and tenant leasehold areas for its system of four airports. To support these efforts, an allowance account would be established to allow Ricondo to assist the DOA with appraisal efforts that require a quick-turnaround on an as-needed basis.

It is mutually understood that work under the Miscellaneous Appraisal Services would only be undertaken when requested by staff from the DOA. Services performed under this Professional Services Authorization would be compensated on a lump sum basis under the Master Agreement Resolution Number R2022-0888 (Solicitation DOA 21-11) for Airport Planning Consulting Services between Ricondo & Associates and the DOA.
