## I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to: A) accept** on behalf of the Palm Beach County Sheriff's Office (PBSO), a second donation from the Howard E. Hill Foundation, Inc., in the amount, of \$25,000 for the period October 16, 2024 through September 30, 2025; and **B) approve** a Budget Amendment of \$25,000 in the Sheriff's Grant Fund.

**Summary:** On April 1, 2025, the Board of County Commissioners (BCC) accepted a \$25,000 Grant Award on behalf of the PBSO from the Howard Hill Foundation, Inc. for the period October 16, 2024 through September 30, 2025, to offset the contractual services cost of a ShotSpotter System for our Gunfire Detection and Location Project. On April 22, 2025, the Howard Hill Foundation awarded an additional \$25,000 donation to continue to support the ShotSpotter System. <u>Countywide</u> (RS)

**Background and Justification:** The donated funds will support the Gunfire Detection and Location Project within the western communities of Palm Beach County.
