I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Amendment No. 1 to Agreement No. LPA0356 (Agreement) with the Florida Department of Environmental Protection (FDEP), for the culvert replacement project (Project) in Loxahatchee River Battlefield Park, extending the expiration date from December 30, 2025 to June 30, 2027 and Project completion date from September 30, 2025 to December 31, 2026.

Summary: This Amendment extends the Agreement (R2023-0193) allowing the Parks and Recreation Department (Parks) additional time needed to complete the Project. Palm Beach County (County) applied for and was awarded a \$125,000 Loxahatchee River Preservation Initiative (LRPI) grant Catalog of Federal Domestic Assistance Number 37.039 to repair four (4) failing culverts at Loxahatchee River Battlefield Park. The Project includes replacing four (4) existing five (5) foot culverts, which are failing and installing two (2) new culverts that will be large enough to allow canoe and kayak passage, thereby opening up additional areas within the park for passive recreation. This Amendment does not affect the overall grant award of \$125,000. **A County match is not required.** District 1 (AH)

Background and Justification: The LRPI funds regional watershed restoration projects within the northeast part of the County and southern Martin County. The LRPI leverages state funds with local funds in a cost-share program aimed at preserving the Loxahatchee River. House member Rick Roth, District 85 sponsored this project, which was selected for funding by the Florida Legislature.

**AMENDMENT NO. 1

This Amendment to Agreement No. LPA0356 (Agreement) is made by and between the Department of Environmental Protection (Department), an agency of the State of Florida, and the PALM BEACH COUNTY (Grantee), on the date last signed below.

WHEREAS, the Department entered into the Agreement with the Grantee for Loxahatchee River Battlefield Park Culvert Replacement Project (Project), effective February 20, 2023; and,

WHEREAS, the Grantee has requested an extension of the Agreement due to delays in permitting and bidding process; and,

WHEREAS, an extension to the Agreement is needed to provide additional time to complete the Project; and,

WHEREAS, other changes to the Agreement are necessary; and,

WHEREAS, the parties have agreed to amend the Agreement as set forth herein.

NOW THEREFORE, the parties agree as follows:

- 1. Section 3. of the Standard Grant Agreement is hereby revised to change the Date of Expiration to June 30, 2027. The Department and the Grantee shall continue to perform their respective duties during this extension period pursuant to the same terms and conditions provided in the Agreement.
- 2. Section 6. of the Standard Grant Agreement is hereby revised to the following:

- 3. The following is hereby added to Attachment 1 in Section 8:
State Funds Documentation. Pursuant to section 216.1366, F.S., if Contractor meets the definition of a non-profit organization under section 215.97(2)(m), F.S., Contractor must provide the Department with documentation that indicates the amount of state funds:
 - i. Allocated to be used during the full term of the contract or agreement for remuneration to any member of the board of directors or an officer of Contractor.
 - ii. Allocated under each payment by the public agency to be used for remuneration of any member of the board of directors or an officer of the Contractor.

The documentation must indicate the amounts and recipients of the remuneration. Such information must be posted on the State's contract tracking system and maintained pursuant to section 215.985, F.S., and must be posted on the Contractor's website, if Contractor maintains a website.

4. Attachment 3, Grant Work Plan, is hereby deleted in its entirety and replaced with Attachment 3-1, Revised Grant Work Plan, as attached to this Amendment and hereby incorporated into the Agreement. All references in the Agreement to Attachment 3 shall hereinafter refer to Attachment 3-1, Revised Grant Work Plan.
5. Attachment 5, Special Audit Requirements, is hereby deleted in its entirety and replaced with Attachment 5-1, Revised Special Audit Requirements, as attached to this Amendment and hereby incorporated into the Agreement. All references in the Agreement to Attachment 5, shall hereinafter refer to Attachment 5-1, Revised Special Audit Requirements.
6. Exhibit A, Progress Report Form, is hereby deleted in its entirety and replaced with Exhibit A-1, attached hereto and made a part of the Agreement. All references in the Agreement to Exhibit A shall hereinafter refer to Exhibit A-1.
7. All other terms and conditions of the Agreement remain in effect. If and to the extent that any inconsistency may appear between the Agreement and this Amendment, the provisions of this Amendment shall control.

**ATTACHMENT 3-1
REVISED GRANT WORK PLAN**

PROJECT TITLE: Loxahatchee River Battlefield Park Culvert Replacement Project

PROJECT LOCATION: The Project will be located in the City of Jupiter within Palm Beach County (Grantee); Lat/Long (26.9328, -80.1783). See Figure 1 for location map.

PROJECT BACKGROUND: Loxahatchee River Battlefield Park and Riverbend Park serve as a recreational gateway to the Northwest Fork of the Loxahatchee National Wild and Scenic River. Continued water flow protects health of the river, prevents flooding of the park property and nearby homes, and expands recreational opportunities within the natural area.

PROJECT DESCRIPTION: The Grantee will replace four failing culverts with two 10’ x 10’ square concrete culverts and complete associated site work, including installation of rip rap, backfill and base rock, and sodding disturbed banks.

TASKS: All documentation should be submitted electronically unless otherwise indicated.

Task 1: Construction

Deliverables: The Grantee will construct two 10’ x 10’ square concrete culverts and complete associated site work, including installation of rip rap, backfill and base rock, and sodding disturbed banks, in accordance with the construction contract documents.

Documentation: The Grantee will submit: 1) a copy of the final design; 2) a signed summary of activities completed for the period of work covered in the payment request, using the format provided by the Department’s Grant Manager. Upon request by the Department’s Grant Manager, the Grantee will provide additional supporting documentation relating to this task.

Performance Standard: The Department’s Grant Manager will review the documentation to verify that the deliverables have been completed as described above. Upon review and written acceptance by the Department’s Grant Manager, the Grantee may proceed with payment request submittal.

Payment Request Schedule: The Grantee may submit a payment request for cost reimbursement no more frequently than quarterly.

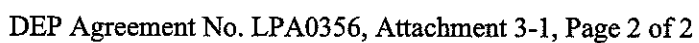

The administration of resources awarded by the Department of Environmental Protection (*which may be referred to as the "Department", "DEP", "FDEP" or "Grantor", or other name in the agreement*) to the recipient (*which may be referred to as the "Recipient", "Grantee" or other name in the agreement*) may be subject to audits and/or monitoring by the Department of Environmental Protection, as described in this attachment.

MONITORING

In addition to reviews of audits conducted in accordance with 2 CFR Part 200, Subpart F-Audit Requirements, and Section 215.97, F.S., as revised (see "AUDITS" below), monitoring procedures may include, but not be limited to, on-site visits by DEP Department staff, limited scope audits as defined by 2 CFR 200.425, or other procedures. By entering into this Agreement, the recipient agrees to comply and cooperate with any monitoring procedures/processes deemed appropriate by the Department of Environmental Protection. In the event the Department of Environmental Protection determines that a limited scope audit of the recipient is appropriate, the recipient agrees to comply with any additional instructions provided by the Department to the recipient regarding such audit. The recipient further agrees to comply and cooperate with any inspections, reviews, investigations, or audits deemed necessary by the Chief Financial Officer (CFO) or Auditor General.

AUDITS

PART I: FEDERALLY FUNDED

This part is applicable if the recipient is a State or local government or a non-profit organization as defined in 2 CFR §200.330

1. A recipient that expends \$1,000,000 or more in Federal awards in its fiscal year, must have a single or program-specific audit conducted in accordance with the provisions of 2 CFR Part 200, Subpart F. EXHIBIT 1 to this Attachment indicates Federal funds awarded through the Department of Environmental Protection by this Agreement. In determining the federal awards expended in its fiscal year, the recipient shall consider all sources of federal awards, including federal resources received from the Department of Environmental Protection. If the recipient expends less than \$1,000,000 in federal awards in its fiscal year and elects to have an audit conducted in accordance with the provisions of 2 CFR 200, Subpart F-Audit Requirements, the cost of the audit must be paid from non-federal resources (i.e., the cost of such an audit must be paid from recipient resources obtained from non-federal entities).

PART II: STATE FUNDED

If the recipient expends less than \$750,000 in state financial assistance in its fiscal year (for fiscal year ending June 30, 2017, and thereafter), an audit conducted in accordance with the provisions of Section 215.97, Florida Statutes, is not required.
