I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: a First Amendment to Contract for Enhanced Mentoring Engagement with Children's Services Council of Palm Beach County (CSC) and United Way of Palm Beach County, Inc. (United Way), to reallocate program funding without changing the total not to exceed contract amount of \$2,064,000 for the period of October 1, 2024 through September 30, 2027. This First Amendment is retroactive to October 1, 2025 to allow United Way to process the Mentor Center Hub payments at the higher rate, beginning with the October 2025 invoice.

Summary: In September 2024, the Board of County Commissioners (BCC) approved a three (3)-year joint funding Contract (R2024-1238) with CSC and United Way for the Enhanced Mentoring Engagement Program (Program). The Program serves youth involved with or at risk of entering the juvenile justice and/or child welfare systems. During fiscal year 2025, the program served 299 youth (including an additional 74 above the contract projected number) and met all Program outcomes. In accordance with the terms of the original Contract, CSC contributes \$380,000 annually, and Palm Beach County (County) provides no more than \$308,000 annually from ad valorem funding. This First Amendment realigns the Schedule of Payments to reflect current operational needs, strengthening hub coordination and ensuring equitable resource distribution to improve service delivery and participant outcomes. Hub payments are made by United Way to providers that engage youth in new experiences through mentor matching. The Hub payments will be increased by \$15,000, and the administrative fee paid to United Way for the administration and oversight of the Program shall decrease by \$15,000. The total not-to-exceed amount of the Contract did not change. Countywide (JBR)

Background and Justification: The Program is jointly funded by the County, CSC, and United Way. The Program provides mentoring and support for youth and families to reduce recidivism, promote well-being and skills for learning and life. Annually, the Program aims to serve approximately 225 youth, 260 parents/caregivers/mentors, and service organization staff. The adjustments included in this First Amendment support increased coordination, training, and operational needs across mentoring hubs to sustain program growth and service quality.

FIRST AMENDMENT TO CONTRACT FOR ENHANCED MENTORING ENGAGEMENT

This First Amendment is made as of <u>December 2, 2025</u>, by and between Palm Beach County, a Political Subdivision of the State of Florida, by and through its Board of Commissioners, hereinafter referred to as the COUNTY, and the Children's Services Council of Palm Beach County, a Political Subdivision of the State of Florida, hereinafter referred to as CSC, each one constituting a public agency as defined in Part I of Chapter 163, Florida Statues, and the United Way of Palm Beach County, Inc., a not-for-profit corporation authorized to do business in the State of Florida, hereinafter referred to as the UNITED WAY, whose Federal I.D. is 59-0683258.

WITNESSETH:

WHEREAS, the parties entered into a jointly funded Contract between CSC, UNITED WAY and the COUNTY dated September 17, 2024, (R2024-1238), to fund the Enhanced Mentoring Engagement program, from October 1, 2024, through September 30, 2027; in an amount not to exceed \$688,000 annually, totaling \$2,064,000 over the three (3) year period;

WHEREAS, the parties desire to amend the original Contract to reallocate \$15,000 of the UNITED WAY Program budget annually to the available Mentor Center Hub Payments by \$15,000 annually;

WHEREAS, the total not-to exceed contract amount remains unchanged.

NOW, THEREFORE, in consideration of the mutual promises contained herein, the COUNTY and the AGENCY agree as follows:

- 1. The foregoing recitals are true and correct and incorporated herein by reference.
- 2. Exhibit A is unchanged and remains valid.
- 3. Exhibit A, Form 1 (Monthly Reports Format) is hereby replaced in its entirety with Exhibit A-1, Form 1 (Monthly Reports Format).
- 4. Exhibit A, Form 2 (Quarterly Reports Format) is unchanged and remains valid.
- 5. Exhibit A, Form 3 (Logic Model) is unchanged and remains valid.
- 6. Exhibit A, Form 4 (Annual Report Format) is unchanged and remains valid.
- 7. Exhibit B is hereby replaced in its entirety with Exhibit B-1.
- 8. This First Amendment shall be retroactive to October 1, 2025.

9. All other provisions of the Contract not modified in this First Amendment remain in full force and effect.
