**FIRST AMENDMENT TO CONTRACT FOR CONSULTING/PROFESSIONAL IN THE
AREA OF VETERINARY/MEDICAL SERVICES**

This First Amendment to the Contract is made as of the 2 day of December, 2025, by and between Palm Beach County, a Political Subdivision of the State of Florida, by and through its Board of Commissioners, hereinafter referred to as the COUNTY, and The Darbster Foundation, Inc. (DARBSTER), a Not for Profit Corporation authorized to do business in the State of Florida, hereinafter referred to as the ENTITY, whose Federal I.D. is 27-0879529.

WITNESSETH

WHEREAS, on December 19, 2023, the parties entered into a Contract for Consulting/Professional Services (R2023-1896), which provided for automatic renewals; and

WHEREAS, the Contract auto-renewed on December 19, 2024 for another one-year term; and

WHEREAS, this First Amendment increases the amount paid to DARBSTER to \$100 per cat and \$125 per dog beginning on December 19, 2025, without changing the not to exceed contract amount of \$200,000; and

WHEREAS, this Amendment adds standard contractual language approved by the Board of County Commissioners after the Contract was executed.

NOW THEREFORE, in consideration of the mutual promises contained herein, the above named parties agree follows:

1. The aforementioned recitals are incorporated herein by reference.
2. On December 19, 2025, Exhibit B shall be replaced with Exhibit B-1.
3. Article 34 titled, "DISCLOSURE OF FOREIGN GIFTS AND CONTRACTS WITH FOREIGN COUNTRIES OF CONCERN" is added:

Pursuant to F.S. 286.101, as may be amended, by entering into this Contract or performing any work in furtherance thereof, the Consultant certifies that it has disclosed any current or prior interest of, any contract with, or any grant or gift received from a foreign country of concern where such interest, contract, or grant or gift has a value of \$50,000 or more and such interest existed at any time or such contract or grant or gift was received or in force at any time during the previous five (5) years.

4. Article 35 titled, "HUMAN TRAFFICKING AFFIDAVIT" is added:

Consultant warrants and represents that it does not use coercion for labor or services as defined in section 787.06, Florida Statutes. Consultant has executed **Exhibit C**, Nongovernmental Entity Human Trafficking Affidavit, which is attached hereto and incorporated herein by reference.

5. Exhibit C of the agreement if hereby added.
6. All other provisions of the Contract shall remain in full force and effect.

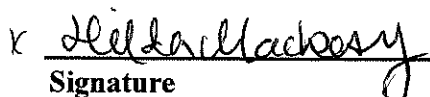

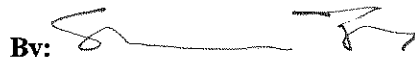

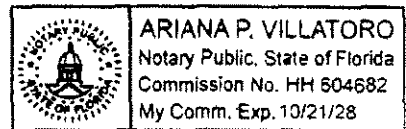
