Background and Justification:



The County has encumbered \$1,500,000 (\$28,037/month) during the previous fifty-three and a half (53.5) months of the current sixty (60) month term contract. The Library Department requests \$1,591,128 to meet the County's requirements through the expiration of this new sixty (60) month term contract for the installation and support of turnkey automated material handling systems. The Agreement contains limitation of liability provisions that differs from that adopted for use by the County under PPM #CW-F-049. The Risk Management Department and County Attorney's office have reviewed the limitation of liability for this Agreement and advised staff accordingly. The Vendor is not liable in tort, contract or otherwise, including negligence, for any business interruption, loss of profits, revenue, or any other special, indirect or consequential loss or any punitive damages relating to the Agreement. Additionally, Lyngsoe Systems, Inc's liability shall not exceed the amounts received by Lyngose from the County pursuant to the order acknowledgement giving risk to the liability. However, Lyngose's total liability for damages caused by defects in the goods, such liability shall not exceed \$2 million per damage and \$20 million per year. Given the type of services being performed under this Agreement, staff is recommending Board approval. These negotiated terms between the County and Lyngsoe Systems, Inc. will be used for future sole source purchases, as applicable. This term contract has no renewal options.
