### I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to approve:** Amendment No. 1 to the 2023 Lift Station Rehabilitation Continuing Construction Contract (Contract) with Hinterland Group, LLC (Contractor) providing for the renewal of the Contract for a one (1) year term.

Summary: On January 23, 2024, the Board of County Commissioners (BCC) approved the Palm Beach County Water Utilities Department (PBCWUD) Contract (R2024-0069) with Contractor. The Contract will be used to expedite utility capital improvement projects, facilitate the completion of much needed rehabilitation work and reduce the response time for corrective action/repairs for any necessary emergency lift station projects throughout PBCWUD's service area where timing is critical. The Contract was approved with a not to exceed amount of The unit prices contained in the Contract will be used to determine the amount of each Work Order. The Contract does not guarantee or authorize the Contractor to perform any work. The Contract has a two (2)-year term with one (1) optional one (1)-year renewal. Amendment No. 1 renews the Contract for a one (1)-year term and does not involve any cost increase to the Contract amount. On October 15, 2025, Palm Beach County Water Utilities Department (PBCWUD) and the Contractor executed an Assignment, Assumption, and Consent Agreement (Agreement) related to this Contract. The purpose of this Agreement was to formally document and approve the Contractor's corporate name change from Hinterland Group Inc. to Hinterland Group, LLC. Through this Agreement, all rights, responsibilities, and obligations under the original Contract were formally assigned and assumed by the newly named entity, ensuring continuity of services and contractual compliance without interruption.

This Contract was presented to the Goal Setting Committee (Committee) on June 7, 2023, and the Committee established an Affirmative Procurement Initiative (API) of a minimum mandatory 20% Small Business Enterprise (SBE) subcontracting participation. Contractor committed to 26.14% SBE participation. To date, the overall participation achieved on this Contract is 16.44%. Contractor is a Palm Beach County based company. The Contract is included in the PBCWUD FY 2026 Budget. (PBCWUD Project No. 23-031) Countywide (MWJ)

**Background and Justification:** The PBCWUD owns and operates over 1,000 wastewater lift stations as part of the wastewater collection system throughout the PBCWUD service area. The Contract will reduce the time needed to undertake the rehabilitation of infrastructure necessary to complete required utility repairs and improvements. This rehabilitation of existing wastewater lift stations will improve the service level; extend the reliability and operability of PBCWUD's wastewater lift stations while reducing the operations and maintenance workload.

# AMENDMENT NO. 1 TO THE 2023 LIFT STATION REHABILITATION CONTINUING CONSTRUCTION CONTRACT PBCWUD PROJECT NO. 23-031 WITH HINTERLAND GROUP, LLC

This Amendment No. 1 dated Link to the 2023 Lift Station Rehabilitation Continuing Construction Contract – PBCWUD Project No. 23-031 (R2024-0069) ("Contract") dated January 23, 2024 by and between **Palm Beach County**, a political subdivision of the State of Florida, by and through its Board of County Commissioners, hereinafter referred to as the COUNTY, and **Hinterland Group**, **LLC**, a Limited Liability Company authorized to do business in the State of Florida, hereinafter referred to as the CONTRACTOR whose Federal I.D. is 20-5156844.

#### WITNESSETH

WHEREAS, the parties have entered into the Contract under which the CONTRACTOR provided certain construction services to the COUNTY for various Lift Station projects in accordance with the Contract; and

WHEREAS, the parties hereto desire to renew the Contract for an additional one (1) year period; and

**NOW, THEREFORE,** in consideration of the premises and of the mutual covenants hereinafter set forth and for such other good and valuable consideration, the receipt of which the parties hereto expressly acknowledge, the parties covenant and agree to the following terms and conditions:

- Pursuant to the Supplemental General Conditions of the Contract, the term of this Contract is renewed for one (1) additional year from January 23, 2026, to January 22, 2027, with no more renewal options remaining.
- The period of service shall continue until completion of all outstanding Work Orders issued within the period of this Contract, unless otherwise terminated as provided herein.
- The Contract cumulative amount not to exceed \$13,686,110.10 is not being increased.
- 4. Except as specifically modified above, the terms and conditions of the

Contract as amended by this Amendment No. 1, are hereby confirmed and remain in full force and effect.


