

Motion and Title: Staff recommends motion to receive and file: Three (3) Standard Potable Water and Wastewater Development Agreements for the months of August and October 2025.

- A) Standard Potable Water and Wastewater Development Agreement with 7281 LWR, LLC, SDA #02-01182-000 (District 3), Recorded in OR BK 35956 PG 374.
- B) Standard Potable Water and Wastewater Development Agreement with Job-Man Development LLC, SDA #05-11148-000 (District 5), Recorded in OR BK 35956 PG 365.
- C) Standard Potable Water and Wastewater Development Agreement with Shadowwood (EDENS), LLC, SDA #09-01109-000 (District 5), Recorded in OR BK 36067 PG 1022.

Summary: In accordance with County PPM CW-O-051, all delegated contracts/agreements/grants/procurement items must be submitted by the initiating Department as a receive and file agenda item and are attached unless the documents have been recorded in the Public Records of Palm Beach County. The documents have been fully executed on behalf of the Board of County Commissioners (BCC) by the Director of the Palm Beach County Water Utilities Department (PBCWUD) in accordance with Resolutions R93-1619, R96-0228, and R2003-0539 and are now being submitted to the BCC to receive and file. Districts 3 & 5 (MWJ)

Background and Justification: PBCWUD's Uniform Policies and Procedures require Standard Development Agreements to obtain concurrency for water and/or wastewater service. The terms and conditions for Standard Development Agreements are outlined in the PBCWUD Uniform Policies and Procedures Manual. The BCC delegated the authority to execute various types of Standard Development Agreements, and related documents including Standard Indemnity Agreements to the Department Director including potable water and wastewater agreements (R93-1619); reclaimed water agreements (R96-0228); and additional conditions for potable water, wastewater, and reclaimed water agreements (R2003-0539).

- A) Standard Potable Water and Wastewater Development Agreement with 7281 LWR, LLC, SDA #02-01182-000 (District 3), Recorded in OR BK 35956 PG 374. This Agreement authorizes the Property Owner located along the north side of Lake Worth Road, west of Pinehurst Drive and east of Nassau Road, 20.30 Equivalent Residential Connections (ERC's) for both water and wastewater for five (5) years.
- B) Standard Potable Water and Wastewater Development Agreement with Job-Man Development LLC, SDA #05-11148-000 (District 5), Recorded in OR BK 35956 PG 365. This Agreement authorizes the Property Owner located along the north side of Boynton Beach Boulevard just east of Jog Road, 41.50 ERC's for water and wastewater for five (5) years.
- C) Standard Potable Water and Wastewater Development Agreement with Shadowwood (EDENS), LLC, SDA #09-01109-000 (District 5), Recorded in OR BK 36067 PG 1022. This Agreement authorizes the Property Owner located on the northeast corner of State Road 7 and Glades Road, 116.80 ERC's for water and wastewater for five (5) years.
