**AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA AMENDING THE BOUNDARIES OF TWO OF THE SEVEN COUNTY COMMISSION DISTRICTS; PROVIDING FOR PUBLICATION; PROVIDING FOR MINUTES; PROVIDING FOR REPEAL OF LAWS IN CONFLICT; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE OF LAWS AND ORDINANCES; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, Article VIII, Section 1(e), of the Florida Constitution requires that, after each decennial census, the Board of County Commissioners (“BCC”) shall divide the county into districts of contiguous territory as nearly equal in population as practical; and

**WHEREAS**, Section 124.01(3), Florida Statutes, provides that the BCC shall, from time to time, fix the boundaries of the county commissioners' districts so as to keep them as nearly equal in proportion to population as practical, provided that changes made in the boundaries of districts may not be made in the 270 days before a regular general election for the BCC, and districts may not be drawn with the intent to favor or disfavor a candidate or incumbent based on residential address; and

**WHEREAS**, on December 7, 2021, following the 2020 census, the BCC adopted Ordinance 2021-036 revising its seven (7) commission districts in accordance with applicable State and Federal law; and

**WHEREAS**, it has come to the BCC's attention that, when the BCC revised the commission districts, there was an oversight in the drawing of the district boundary between Districts 2 and 7, such that a small portion of the residential community of Century Village became separated into the two (2) different commission districts; and

**WHEREAS**, the subject area is the small portion of Century Village north of a canal, which otherwise serves as the northern boundary of Century Village and which contains a total of 152 residents; and

**WHEREAS**, it was not the intention of the BCC to sever this small portion of the residential community of Century Village between two (2) different commission districts and, indeed, prior to the 2021 redistricting the entire community of Century Village resided within District 2; and

**WHEREAS**, in accordance with all applicable State and Federal law, given the small population at issue and the hardships and confusion imposed upon the community, the BCC desires

to repair the oversight previously committed, to ensure the entire residential community of Century Village remains in the same District, namely District 2, by modifying the applicable boundary between Districts 2 and 7 as set forth below; and

**WHEREAS**, all other county commission districts shall remain as presently constituted.

**NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:**

**SECTION 1. District Boundaries**

The boundaries of District 2 and District 7 are hereby changed to conform to the legal descriptions attached hereto and made a part hereof as Exhibit "A." All other commission district remain as presently constituted and are restated in their unchanged form on the attached Exhibit "A."

**SECTION 2. Publication**

Pursuant to §124.02, Florida Statutes, a certified copy of this Ordinance, including an accurate description of the boundaries of the districts, shall be published once each week for two (2) consecutive weeks in a newspaper published in Palm Beach County, and proof of such publication shall be entered on the minutes of the Board.

**SECTION 3. Minutes**

Pursuant to §124.03, Florida Statutes, the Clerk of the BCC shall forthwith furnish the Department of State a certified copy of the Minutes of the BCC meeting reflecting the description of the boundaries of the districts as set forth in this Ordinance.

**SECTION 4. Repeal of Laws in Conflict**

All local laws and ordinances in conflict with any of the provisions of this Ordinance are hereby repealed.

**SECTION 5. Severability**

If any section, paragraph, sentence, clause, phrase, or word of this Ordinance is for any reason held by a Court to be unconstitutional, inoperative or void, such holding shall not affect the remainder of this Ordinance.

**SECTION 6. Inclusion in the Code of Laws and Ordinances**

The provisions of this Ordinance shall become and be made a part of the Code of Laws and Ordinances of Palm Beach County, Florida. The sections of this Ordinance may be renumbered or

65 relettered to accomplish such, and the word "ordinance" may be changed to "section," "article," or  
66 any other appropriate word.

67 **SECTION 7. Effective Date**

68 The provisions of this Ordinance shall become effective upon filing with the Department of State.

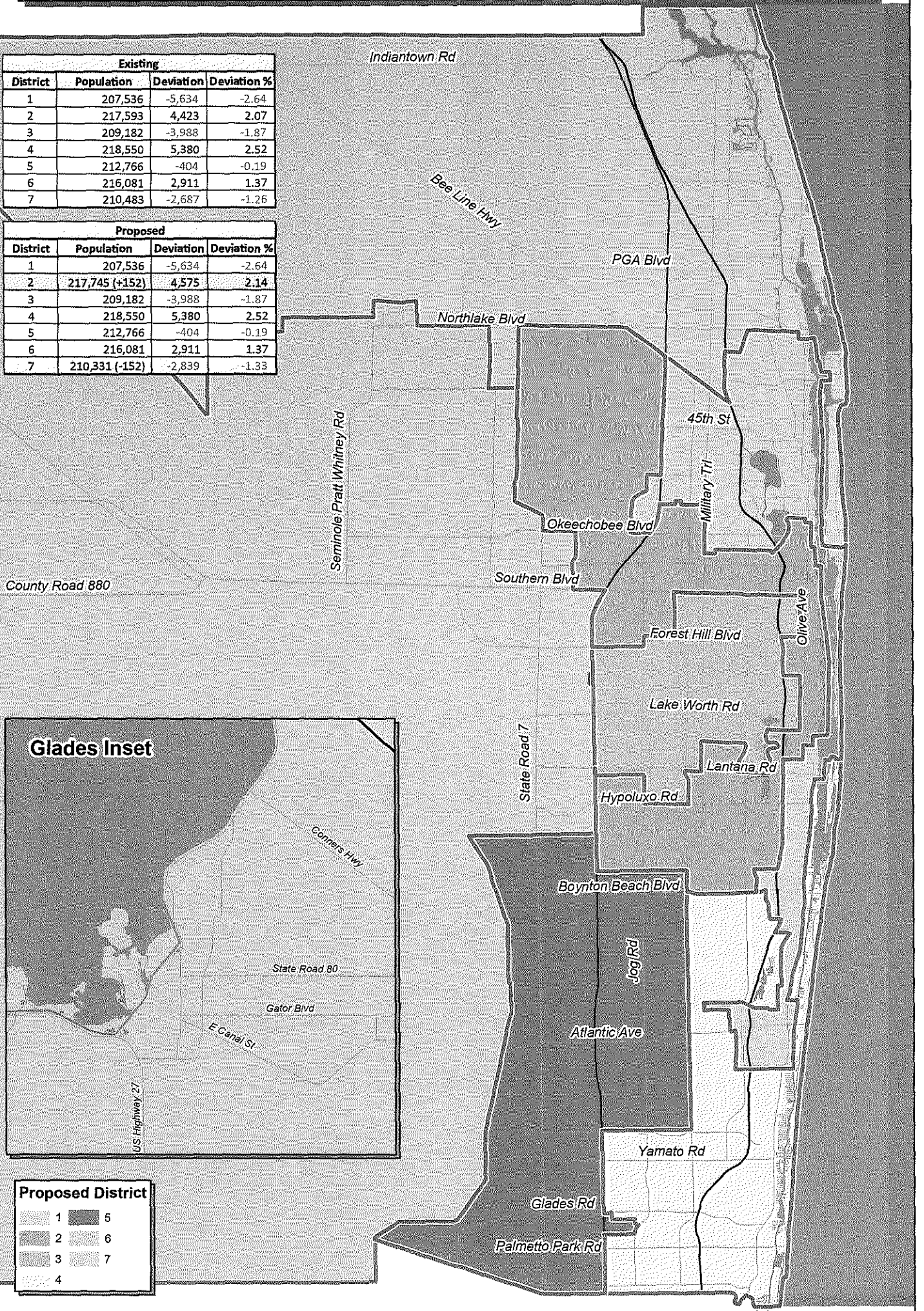

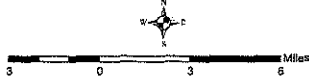
