I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve:




- A) Resolution of the Board of County Commissioners (Board) of Palm Beach County, Florida, approving Budget Transfers and Budget Amendments relating to the transfer of Ocean Rescue Lifeguards to the Fire Rescue Department; and providing for an effective date.
- B) Budget Transfer of \$7,869,401 within the General Fund to Fire Rescue MSTU Fund, \$7,169,401 from Parks and Recreation Department (Parks) and \$700,000 from Contingency Reserves to fund the transfer of Ocean Rescue Lifeguards and additional communication equipment;
- C) Budget Transfer of \$295,338 within the Facilities Development and Operations (FDO) Fleet Management Fund to the Fire/Rescue MSTU Fund to fund the transfer of Ocean Rescue Equipment and Vehicles;
- D) Budget Amendment of \$ 8,164,739 within the Fire/Rescue MSTU Fund to recognize the transfers from Parks and FDO Fleet Management;
- E) Budget Transfer of \$127,200 within the Parks Improvement Fund to Fire Rescue Improvement Fund to fund the repairs and renovations of Ocean Rescue Equipment; and
- F) Budget Amendment of \$127,200 within the Fire/Rescue Improvement Fund to recognize the transfer from Parks Improvement Fund to fund the repairs and renovations of Ocean Rescue Equipment.

Summary: The Palm Beach County (PBC) Ocean Rescue Lifeguards are a United States Lifesaving Association (USLA) certified team of well trained, highly skilled professionals operating under Parks. They provide the initial response to emergencies on and in PBC managed beaches, providing ocean rescues, emergency medical care, and preventative interventions, as well as assistance to beachgoers. Fire Rescue is requesting Budget Transfers and Budget Amendments relating to the transfer of the Ocean Rescue Lifeguard Section and related vehicles and equipment from Parks to Fire Rescue. This action will establish a new division within Fire Rescue to align all water emergency response functions under a single public safety agency. **Countywide (SB)**

Background and Policy Issues: Continued from page 1. The Ocean Rescue Lifeguards are entrusted with protecting and servicing an estimated 5.2 million beachgoers every year, averaging 200 rescues, 630 bathing assists, 16,000 first aid cases, 113,000 preventative actions, and reuniting 30 lost children with their parents, as well as 9,000 participants in their public education events. Fire Rescue is an ISO Class 1 all-hazards fire and rescue department responding to over 154,000 calls for help each year addressing a wide variety of emergencies.

A new division will be established within Fire Rescue to consolidate all PBC water response services. Fire Rescue will work with staff to ensure a smooth transition while continuing to provide the superior service delivery both departments are accustomed to. This proposed transfer aims to enhance water safety and increase efficiency in emergency response in PBC through a single coordinated effort. The benefits of the new division to the residents of PBC will include; enhanced water safety, increased efficiency, strategic alignment, extensive training and certified instructors.

RESOLUTION NO. R2026-_____

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS (BOARD) OF PALM BEACH COUNTY, FLORIDA, APPROVING BUDGET TRANSFERS AND BUDGET AMENDMENTS RELATING TO THE TRANSFER OF OCEAN RESCUE LIFEGUARDS TO THE FIRE RESCUE DEPARTMENT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the transfer of Ocean Rescue Lifeguards, Equipment and Vehicles to the Fire Rescue Department from the Parks and Recreation Department (Parks) necessitates several Budget Amendments and Budget Transfers between funds to properly account for the unanticipated revenue to, and add appropriations to the budget of, the proper fund; and

WHEREAS, pursuant to Section 129.06(2)(d), Florida Statutes, the Board may by Resolution amend the budget and transfer revenue between funds to account for unanticipated revenue received for a particular purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

Section 1. The Board hereby adopts this Resolution approving the following budget transfers and amendments to the FY 2026 Budget:

- A) Budget Transfer of \$7,869,401 within the General Fund to Fire Rescue MSTU Fund, \$7,169,401 from Parks and Recreation Department (Parks) and \$700,000 from Contingency Reserves to fund the transfer of Ocean Rescue Lifeguards and additional communication equipment;
- B) Budget Transfer of \$295,338 within the Facilities Development and Operations (FDO) Fleet Management Fund to the Fire/Rescue MSTU Fund to fund the transfer of Ocean Rescue Equipment and Vehicles;
- C) Budget Amendment of \$8,164,739 within the Fire/Rescue MSTU Fund to recognize the transfers from Parks and FDO Fleet Management;
- D) Budget Transfer of \$127,200 within the Parks Improvement Fund to Fire Rescue Improvement Fund to fund the repairs and renovations of Ocean Rescue Equipment; and
- E) Budget Amendment of \$127,200 within the Fire/Rescue Improvement Fund to recognize the transfer from Parks Improvement Fund to fund the repairs and renovations of Ocean Rescue Equipment.

Section 2. Effective Date

The provisions of this Resolution shall be effective immediately upon adoption hereof.


