**I. EXECUTIVE BRIEF**

**Motion & Title:** Staff recommends motion to approve: the appointment of West Palm Beach Commissioner Ms. Christy Fox as an At-large member to the Palm Beach County Tourist Development Council (TDC) to complete an unexpired term ending September 30, 2026 and complete a full four (4) year term from October 1, 2026 through September 30, 2030.

**Summary:** The TDC was established by Resolution No. R81-275, adopted March 3, 1981; Chapter 125.0104, Florida Statutes LOCAL OPTION TOURIST DEVELOPMENT ACT, Palm Beach County Code 17-111. Under Ordinance 95-30, as amended, adopted August 15, 1995, TDC has nine (9) members. One (1) member shall be the Chair of the Board of County Commissioners (BCC) or designee who shall serve as the Chair of the TDC. Of the remaining eight (8) members appointed by the BCC, two (2) members shall be elected municipal officials, one (1) of whom shall be from the most populous municipality in Palm Beach County, this is the at-large seat being filled today, three (3) owners or operators of motels, hotels, recreational vehicle parks, or other tourist accommodations in the County and subject to the tax, and three (3) members who are involved in the tourist industry and who have shown an interest in tourist development, but who are not owners or operations of motels, hotels, recreational vehicle parks or other tourist accommodations in the County and subject to the tax. **Countywide (YBH)**

**Background and Justification:** The membership of the TDC consists of two (2) elected government officials, three (3) owners or operators of motels, hotels, recreational vehicle parks or other tourist accommodations in the County and subject to the tax, and three (3) who are involved in the tourist industry and who have shown an interest in tourist development, but who are not owners or operations of motels, hotels, recreational vehicle parks or other tourist accommodations in the County and subject to the tax. TDC prepares a plan for tourist development (Plan); this Plan establishes the uses of the tax revenue by specific project or special use as authorized in Section 125.0104, Florida Statutes.



Christy Fox, a Palm Beach County native, has served as City Commissioner for District 3 in West Palm Beach since 2020. She is focused on advancing policies that enhance quality of life, strengthen community connections, and support thoughtful, well-planned growth—while ensuring residents and stakeholders have a voice in the decision-making process.

A marketing and public relations executive, Christy spent nearly a decade with the Monuments Men Foundation, where she played a key role in securing the Congressional Gold Medal for the Monuments Men and worked on two *New York Times* bestselling books, including *The Monuments Men*, later adapted into a major motion picture. She now works as a marketing consultant, advising authors and nonprofit organizations.

Christy was one of just 15 elected officials nationwide selected for Smart Growth America's Champions Institute, a year-long program focused on creating safer, more accessible, and complete streets. She was also named a "Champion of Change" by the Grow Lit Project for her work supporting literacy in underserved communities.

Christy holds a Bachelor of Science degree from Boston University's College of Communication. She serves on several boards on behalf of the City of West Palm Beach, including the Mandel Public Library and the Executive Board of the Palm Beach County Metropolitan Planning Organization. She remains committed to thoughtful planning, civic engagement, and expanding opportunities for all residents.
