I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to: A) accept on behalf of the Palm Beach County Sheriff's Office (PBSO), a second donation from the Howard E. Hill Foundation, Inc., in the amount, of \$25,000 for the period November 20, 2025 through September 30, 2026; and B) approve a Budget Amendment of \$25,000 in the Sheriffs Grant Fund.

Summary: On March 3, 2026, the Board of County Commissioners (BCC) accepted a \$25,000 donation on behalf of the PBSO from the Howard Hill Foundation, Inc. for the period November 20, 2025 through September 30, 2026, to offset the contractual services cost of a ShotSpotter System for the Gunfire Detection and Location Project (R3CC-1). On June 11, 2026, the Howard Hill Foundation awarded an additional \$25,000 donation to continue to support the ShotSpotter System. The total donation is \$50,000. Countywide (RS)

Background and Justification: The donated funds will support the Gunfire Detection and Location Project within the western communities of Palm Beach County.

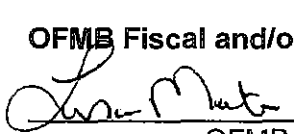

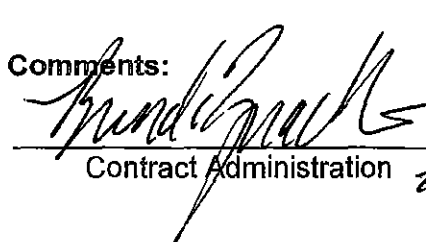
