I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Budget Transfer of \$450,000 within the 1999 \$25M General Obligation (GO) Recreation & Cultural Bond Fund from reserves to Therapeutic Recreation Complex.

Summary: The Therapeutic Recreation Complex project is currently under construction and includes the construction of a new Very Special Arts, Art Gallery Building and Special Olympics Gymnasium, as well as the remodeling of the existing pool and bathhouse. This transfer is necessary to fund substantial costs not included in the Construction Manager at Risk contract with Centex Construction Company, LLC, and is possible using reserves from the 1999 \$25M GO Recreation & Cultural Bond Fund. <u>Countywide/District 3 (AH)</u>

Background and Justification: The Therapeutic Recreation Complex project is reaching completion, and additional funding is necessary for significant expenditures not covered in the contract with Centex Construction Company, LLC. These unanticipated costs include Florida Department of Transportation requirements for turn lane and median improvements on Lake Worth Road, utility fees, and additional site improvements. Funding for this budget transfer is available from reserves in 1999 \$25M GO Recreation & Cultural Bond Fund, and will provide necessary funding to complete this project.
