Review of the ordinance resulted in a recommended change to the Professions, businesses, occupations classification, to remove an exemption for persons, licensed by law under a regulatory statute, who are under the direct supervision of another person. The removal of the exemption was consistent with Florida Statute, Chapter 205. The occupational license fee for this classification is \$33 per year and \$16.50 for a half year. Since the implementation of Ordinance 2005-10, the County has issued over 1700 licenses to real estate associates and collected over \$33,000 in
