PURPOSE:

To establish the County policy on the use, possession or sale of alcoholic beverages in all County facilities and on all County property.

UPDATES:

Future updates to this PPM are the responsibility of the Director of FDO.

AUTHORITY:

- Palm Beach County Code, Section 2-20(8), as may be amended;
- Palm Beach County Code, Section 2-21(3), as may be amended;
- Palm Beach County Code, Section 21-33(c) and (d), as may be amended;
- Palm Beach Administrative Code, Section 302.00, as may be amended.

SCOPE:

This PPM shall apply to the use, possession or sale of alcoholic beverages in all County facilities and on all County property.

POLICY:

The use, possession or sale of alcoholic beverages by either occupants or visitors is strictly prohibited in all County facilities and on all County property except as follows:

1. Where the use, possession or sale of alcoholic beverages are included as a specifically stated responsibility of a facility operator operating pursuant to an agreement

approved by the Board of County Commissioners, in which case the terms of the facility operator's agreement shall prevail; or

- 2. Pursuant to sections 21-33(c) and (d), Palm Beach County Code, whereby the Parks and Recreation Department Director has designated a specific area of park property in which alcoholic beverages may be possessed or consumed or where the Parks and Recreation Department Director permits, in writing, the sale, possession, and/or consumption of alcoholic beverages incidental to a special event, said permission not to exceed four (4) consecutive days.
- 3. Pursuant to the terms of a County Facility Use Permit issued pursuant to the terms of PPM CW-O-024, whereby the County Administrator has approved the use, possession or sale of alcoholic beverages in a County facility or on County property for an event, provided that, such permit contains requirements for liquor liability insurance as well as other special conditions applicable to the requested event.
