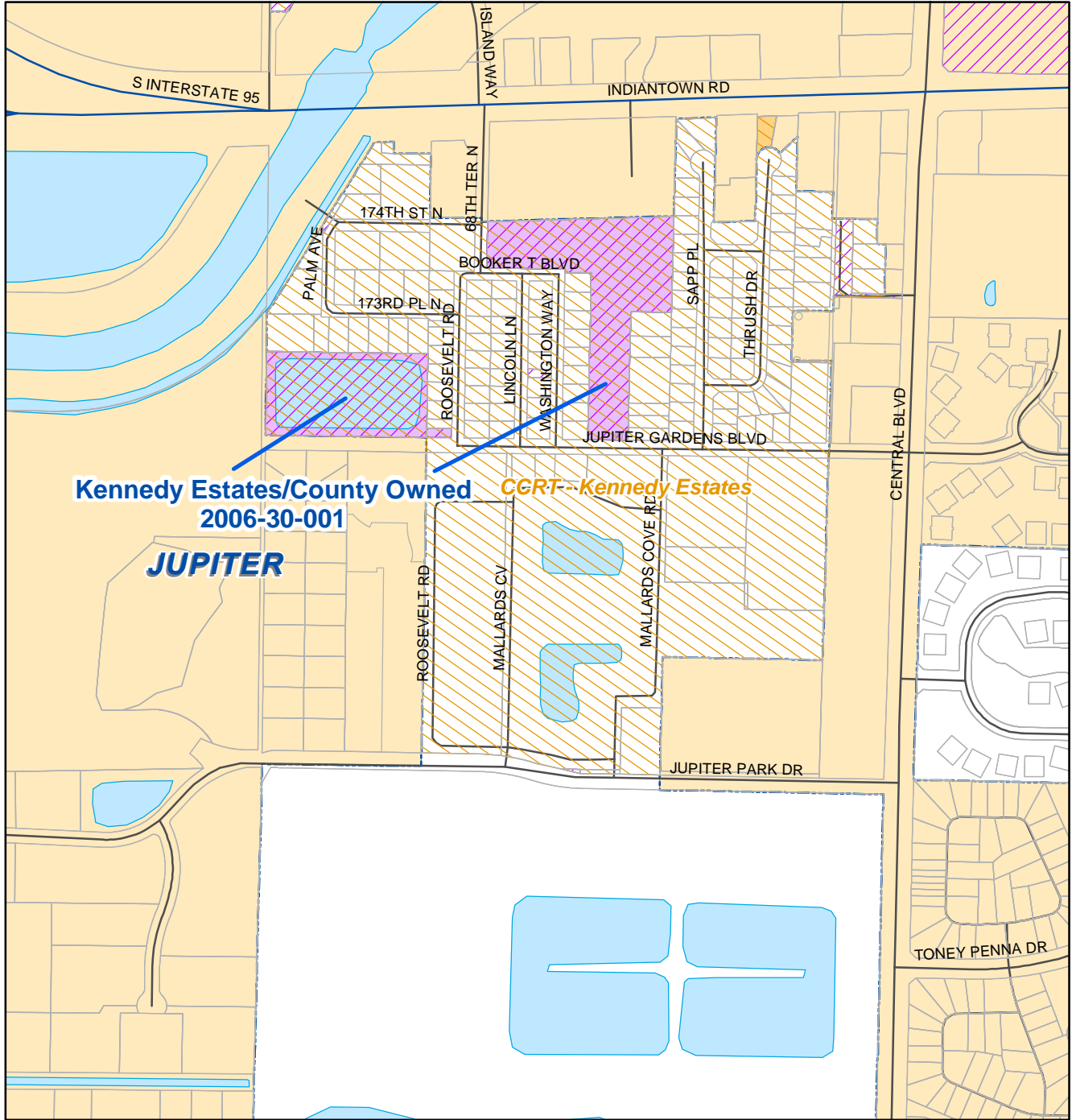

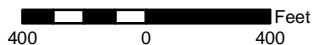
# Annexation Location Map
