

RESOLUTION REQUESTING THAT THE ZONING COMMISSION OF PALM BEACH COUNTY, FLORIDA, ADOPT AND ENFORCE A BUILDING SETBACK OF NINETY (90) FEET ON EACH SIDE OF THE CENTERLINE, AS LAID OUT AND IN USE, FOR SR-809 (MILITARY TRAIL) FROM SCHALL ROAD TO PGA BOULEVARD AND, FURTHER, FROM PGA BOULEVARD NORTH ANY EXTENSION THEREOF

WHEREAS, the Board of County Commissioners of Palm Beach County have found that it is in the interest of public safety and welfare that a minimum building setback be established on each side of the centerline of SR-809 (Military Trail) from Schall Road to PGA Boulevard and on any extension northward thereof because of extreme vehicular traffic demands on and projected for this arterial highway facility;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, in regular session assembled on this 13th day of April, 1971, that the Zoning Commission of Palm Beach County, Florida, be requested to adopt and enforce the building setback of ninety (90) feet on each side of the centerline, as laid out and in use, or on any northward extension thereof for the following arterial State highway:

STATE ROAD 809 - Military Trail - from Schall Road to PGA Boulevard and, further, from PGA Boulevard north any extension thereof.

BE IT FURTHER RESOLVED that a copy of this resolution shall be forwarded to the Palm Beach County Zoning Commission for consideration and action.

The foregoing resolution was offered by Commissioner Lytal who moved its adoption. The motion was seconded by Commissioner

Weaver, and upon being put to a vote, the vote was as follows:
