ZONING RESOLUTION NO. R-71-342

ADOPTED September 16, 1971

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, in regular session assembled this the 16th day of September 1971, adopted as an Amendment to Zoning Resolution No. 3-57, pursuant to the authority vested in said Commission by Chapter 57-1691, Special Laws of Florida 1957, Chapter 59-1686, Special Laws of Florida 1959, and Chapter 70-863 Special Laws of Florida 1970:

The West 54.35 feet of Lot 6, all of Lots 7, 8, 9, 10, 11, 12, 13 and the East 45.15 feet of Lot 14 of Lake Osborne Subdivision, according to the Plat thereof recorded in Plat Book 9, Page 42, Palm Beach County Records, and all that part of Government Lots 2 and 3 in Section 5, Township 45 South, Range 43 East, lying East of Via Vermilya Street as shown in plat of Lanair Park, recorded in Plat Book 21, Page 58, Palm Beach County Records and lying North of the edge of the Lagoon as the same appears shown upon said plat and West of the East line of the West 54.35 feet of Lot 6, Lake Osborne Subdivision extended and South of the West 54.35 feet of Lot 6, all of Lots 7, 8, 9, 10, 11, 12, 13 and the East 45.15 feet of Lot 14, and all that area covered by water as shown and according to plat of Lanair Park, Plat Book 21, Page 58, Palm Beach County records, which lies East of Via Vermilya and North of Lot 1, Block 1, and Lots 1, 2, 3, 4 in Block 4, according to the recorded plat of Lanair Park, recorded in Plat Book 21, Page 58, Palm Beach County Records, bounded on the East by the extension of the East line of the West 54.35 feet of Lot 6 extended, bounded on the North by the North edge of said Lagoon, and bounded on the West by the East line of Via Vermilya, and that certain canal right-of-way known as Lake Worth Drainage District Lateral No. 16 lying North of and adjacent to the West 54.35 feet of Lot 6, all of Lots 7, 8, 9, 10, 11, 12, 13 and the East 45.15 feet of Lot 14, bounded on the West by the East line of Via Vermilya, on the North by the South line of Lantana Road, on the East by an extension of the East line of the West 54.35 feet of Lot 6, Lake Osborne Subdivision Plat Book 9, Page 42 is hereby rezoned from R-1A Single Family Dwelling District to R-2A Multiple

Family Dwelling District.

The foregoing resolution was offered by Commissioner Johnson, who moved its adoption. The motion was seconded by Commissioner Lytal, and upon being put to a vote, the vote was as follows:

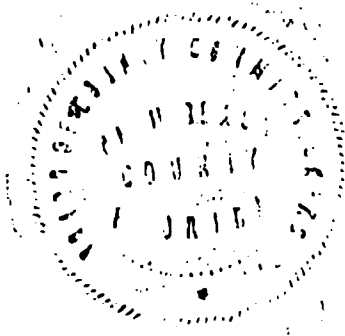
The Chairman thereupon declared the resolution duly passed and adopted this 16th day of September 1971.
