ZONING RESOLUTION NO. R-72-39

MODIFYING THE DISTRICT BOUNDARIES

ADOPTED January 20, 1972

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, in regular session assembled this the 20 day of January, 1972, adopted as an Amendment to Zoning Resolution No. 3-57, pursuant to the authority vested in said Commission by Chapter 57-1694, Special Laws of Florida 1957, Chapter 59-1686, Special Laws of Florida 1959, and Chapter 70-863, Special Laws of Florida 1970:

That portion of the Central and Southern Florida Flood Control Easement, lying in Section 31, Township 42 South, Range 43 East; described as follows: begin at the Northwest corner of the Northeast 1/4 of said Section 31; thence run South $2^{\circ} 23' 08''$ West, along the West line of the Northeast 1/4 of said Section 31, for a distance of 1358.01 feet to a point; thence run North $87^{\circ} 39' 12''$ West, for a distance of 60 feet to a point; thence run North $2^{\circ} 23' 08''$ East, 60 feet West of and parallel to the West line of the Northeast 1/4 of said Section 31, for a distance of 1357.68 feet, to a point on the North line of said Section 31; thence run Easterly along the North line of said Section 31, for a distance of 60 feet, to the point of beginning is hereby rezoned from M-1 Industrial District to R-1AA Single Family Dwelling District.

The foregoing resolution was offered by Commissioner Lytal, who moved its adoption. The motion was seconded by Commissioner Warren, and upon being put to a vote, the vote was as follows:


