RESOLUTION NO. R-73-233

RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, and Chapter 70-863, Laws of Florida, Special Acts of 1970, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 73-26 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on 26 April 1973.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this 26th day of April, 1973, that the Board authorized the advertisement of the following Ordinance Amendment to the Palm Beach County Zoning Code:

73-26 The petition of WILLIAM R. BOOSE, DIRECTOR OF PLANNING, ZONING AND BUILDING, to AMEND THE PALM BEACH COUNTY ZONING CODE, as follows:

UNDER SECTION 602 - RE RESIDENTIAL ESTATE DISTRICT, Paragraph B - PERMITTED USES, add the following:

- PRIVATE KENNELS OR STABLE FACILITIES or other uses customarily incidental to the principal residential use provided that animals are not kept for sale or resale nor for commercial purposes including breeding, boarding or veterinary care

NON-COMMERCIAL KEEPING OR RAISING OF HORSES, without stable facilities or other customary incidental accessory uses or buildings

The foregoing resolution was offered by Commissioner Culpepper, who moved its adoption. The motion was seconded by Commissioner Warren, and upon being put to a vote, the vote was as follows:
