

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, AMENDING RESOLUTION NO. R-81-1371, WHICH APPROVED ZONING PETITION NO. R-81-166, TO CORRECT THE ZONING DISTRICT DESIGNATION.

WHEREAS, Christine N. Gabel, Trustee, petitioned the Palm Beach County Planning Commission and the Board of County Commissioners, sitting as the final zoning authority for the rezoning from AG-Agricultural District to RM-Residential Multiple Family District (Medium Density) on a parcel of land located on the West side of Military Trail (S.R. 809) approximately .3 mile north of L.W.D.D. Lateral Canal No. 37; and

WHEREAS, Petitioner amended the petition to a request for rezoning to RS-Residential Single Family District; and

WHEREAS, Resolution No. R-81-1371, adopted October 27, 1981, confirming the action of the Board of County Commissioners sitting as the final zoning authority on September 24, 1981, did not reflect the amended request.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

1. The foregoing recitals are hereby affirmed and ratified.
2. Resolution No. R-81-1371 is hereby amended as to the action of the board as follows:

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this 24th day of September, 1981, that Resolution No. 81-166, the petition of CHRISTINE N. GABEL, TRUSTEE, for the Rezoning, from AG-Agricultural District to RM-Residential Multiple Family District (Medium Density) as amended per the petitioner's request for the Rezoning from AG-Agricultural District to RS-Residential Single Family District, of the North 3/4 of the South 1/2 of the Northeast 1/4 of Section 26, Township 46 South, Range 42 East, less the East 620 feet thereof; together with the North 200 feet of the West 545 of the East 620 feet of the South 1/2 of the Northeast 1/4 of said Section 26. Said property located on the West side of Military Trail (S.R. 809), approximately .3 mile North of L.W.D.D. Lateral Canal No. 37, was approved.

The foregoing resolution was offered by Commissioner Bailey who moved its adoption. The motion was seconded by Commissioner Foster and, upon being put to a vote, the vote was as follows:

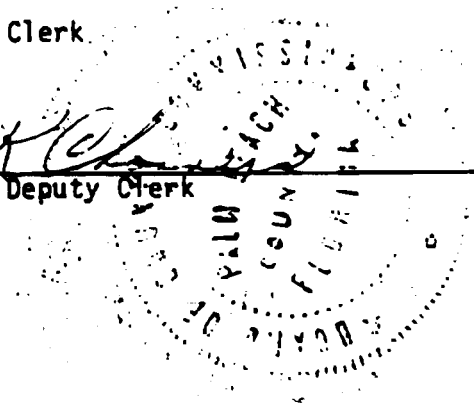
