

RESOLUTION NO. R-88 -195

RESOLUTION WITHDRAWING ZONING PETITION S86-55

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. S86-55 was presented to the Board of County Commissioners of Palm Beach County, sitting as the Zoning Authority, at its public hearing conducted on November 18, 1986 and

WHEREAS, the Board of County Commissioners has considered the evidence and testimony presented by the applicant and other interested parties and the recommendations of the various county review agencies and the recommendations of the Planning Commission; and

WHEREAS, the Board of County Commissioners made the following findings of fact:

1. This proposal is consistent with the requirements of the Comprehensive Plan and local land development regulations.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA that: Petition No. S86-55 (regarding Zoning Petition No. 81-122, Resolution No. R-81-1057) the petition of the Board of County Commissioners, by Karen T. Marcus, Chairman, for the rezoning, from RT-Residential Transitional Zoning District to RE-Residential Estate Zoning District, of all of Tracts 38, 39, 40, 41, 42, 43, 55, 56 and 58, and the West 1/2 of Tracts 54 and 59, all in Block 11, Palm Beach Farms Company Plat No. 3 in Sections 5, 6 7 and 8, Township 44 South, Range 42 East as recorded in Plat Book 2, Page 46, on property located on the north side of Dillman Road and the south side of 5th Street South, bounded on the west by 90th Avenue South was withdrawn, without prejudice.

A motion to withdraw, without prejudice, Petition No. S86-55 was offered by Commissioner Ownes, who moved its adoption. The motion was seconded by Commissioner Adams, and upon being put to a vote, the vote was as follows:
