RESOLUTION AMENDING RESOLUTION NO. R-91-1075
RESOLUTION APPROVING ZONING PETITION OF WAL-MART STORES, INC
~~PETITION NO. 91-6~~

WHEREAS, WAL-MART STORES, INC petitioned the Palm Beach County Planning Commission and the Board of County Commissioners, sitting as the final zoning authority, on March 7, 1991 and May 30, 1991, respectively for the REZONING FROM ~~AR-AGRICULTURAL RESIDENTIAL ZONING DISTRICT TO CG-GENERAL COMMERCIAL ZONING DISTRICT~~, and

WHEREAS, Resolution No R-9 -1075 adopted August 20, 1991, confirming the action of the Board of County Commissioners sitting as the final zoning authority on May 30, 1991, inadvertently contained errors in the legal description, and

WHEREAS, the legal description of Resolution No R-91-1075 reads as follows

"Tract 14, LESS the North 28 feet thereof, Block 81 of PALM BEACH FARMS COMPANY Plat No 3, recorded in Plat Book 2, Pages 45-54, inclusive, as in Section 27, Township 43 South, Range 42 East," and

WHEREAS, the legal description of said zoning resolution should have read:

Tract 14, LESS the North 28 feet thereof, Block 81 of PALM BEACH FARMS COMPANY Plat No 3, recorded in Plat Book 2, Pages 45-54, inclusive, as in Section ~~27~~ 30, Township ~~43~~ 47 South, Range 42 East,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that

- 1 The foregoing recitals are hereby affirmed and ratified
- 2 The legal description of Resolution No R-91-1075 is hereby amended




