RESOLUTION AMENDING RESOLUTION NO R-89-1158
RESOLUTION APPROVING ZONING PETITION OF
RAINBERRY DEVELOPMENT FOUR, INC AND
FIRST AMERICAN EQUITY POLO CORPORATION
PETITION NO 84-71(F)

WHEREAS, RAINBERRY DEVELOPMENT FOUR, INC AND FIRST AMERICAN EQUITY POLO CORPORATION, By Russell Scott, Agent, petitioned the Palm Beach County Planning Commission and the Board of County Commissioners, sitting as the final zoning authority, on September 1, 1988 and December 29, 1988, respectively, for a REZONING FROM THE AR-AGRICULTURAL RESIDENTIAL ZONING DISTRICT TO THE RTS-RESIDENTIAL TRANSITIONAL SUBURBAN ZONING DISTRICT, and

WHEREAS, Resolution No R-89-1158 adopted June 13, 1989, confirming the action of the Board of County Commissioners sitting as the final zoning authority on December 29, 1988, inadvertently contained an error in the rezoning request, and

WHEREAS, the rezoning request of Resolution No 89-1158 reads as follows

"a REZONING FROM AR-AGRICULTURAL RESIDENTIAL ZONING DISTRICT, IN PART RTS-RESIDENTIAL TRANSITIONAL SUBURBAN ZONING DISTRICT, IN PART, AND RS-RESIDENTIAL SINGLE FAMILY ZONING DISTRICT, IN PART, TO RTS-RESIDENTIAL TRANSITIONAL SUBURBAN ZONING DISTRICT, IN PART, AND RS-RESIDENTIAL SINGLE FAMILY ZONING DISTRICT, IN PART," and

WHEREAS, the rezoning request of said zoning resolution should have read

a REZONING FROM THE AR-AGRICULTURAL RESIDENTIAL ZONING DISTRICT TO THE RTS-RESIDENTIAL TRANSITIONAL SUBURBAN ZONING DISTRICT

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that

- 1 The foregoing recitals are hereby affirmed and ratified
- 2 The rezoning request of Resolution No 89-1158 is hereby corrected
