KNOW ALL MEN BY THESE PRESENTS THAT TUSCANY VILLAGE OF BOCA RATON, INC., A FLORIDA CORPORATION, OWNER OF THE LANDS SHOWN HEREON, BEING A REPLAT OF A PORTION OF BLOCKS 1 AND 3 AND THE ADJACENT RIGHTS-OF-WAY, "SUBDIVISION IN LOT 7-SEC.-32-TWP.46S-R43E.", ACCORDING TO THE PLAT THEREOF AS RECORDED IN PLAT BOOK 12. PAGE 83 OF THE PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA, IN SECTION 32, TOWNSHIP 46 SOUTH, RANGE 43 EAST, PALM BEACH COUNTY, FLORIDA, AND SHOWN HEREON AS "TUSCANY VILLAGE". A REPLAT, AND BEING MORE PARTICULARLY DESCRIBED AS

COMMENCING AT THE SOUTHEAST CORNER OF SAID SECTION 32; THENCE SOUTH 89° 31'10" WEST, ALONG THE SOUTH LINE OF SAID SECTION 32, A DISTANCE OF 1400.31 FEET; THENCE NORTH 00° 18'46" WEST, ALONG THE WEST RIGHT-OF-WAY LINE OF STATE ROAD 5 (U.S. 1) AS SHOWN ON THE FLORIDA DEPARTMENT OF TRANSPORTATION RIGHT-OF-WAY MAP (SECTION 9301, DATED 11-13-47), A DISTANCE OF 229.84 FEET TO THE POINT OF CURVATURE OF A CIRCULAR CURVE TO THE RIGHT; THENCE NORTHERLY ALONG THE ARC OF SAID CURVE, AND ALONG SAID WEST LINE, HAVING A RADIUS OF 2951.93 FEET AND A CENTRAL ANGLE OF 02° 46'26", A DISTANCE OF 142.92 FEET TO THE POINT OF BEGINNING; THENCE SOUTH 89° 31'10" WEST, ALONG A LINE 373 FEET NORTH OF AND PARALLEL WITH SAID SOUTH LINE OF SECTION 32, A DISTANCE OF 570.43 FEET; THENCE NORTH 07° 44'46" EAST, ALONG THE EAST RIGHT-OF-WAY LINE OF DIXIE HIGHWAY AS SHOWN IN DEED BOOK 835, PAGE 135 OF SAID PUBLIC RECORDS, A DISTANCE OF 293.02 FEET; THENCE NORTH 89° 31'10" EAST, ALONG A LINE 663 FEET NORTH OF AND PARALLEL WITH SAID SOUTH LINE OF SECTION 32, A DISTANCE OF 598.95 FEET; THENCE SOUTH 10°04'54" WEST, ALONG A LINE 123 FEET WEST OF AND PARALLEL WITH THE EAST RIGHT-OF-WAY LINE OF SAID STATE ROAD 5 AS SHOWN ON THE FLORIDA DEPARTMENT OF TRANSPORTATION RIGHT-OF-WAY MAP (SECTION 9301, DATED 6-17-54), A DISTANCE OF 179.63 FEET TO THE POINT OF CURVATURE OF A CIRCULAR CURVE TO THE LEFT; THENCE SOUTHERLY ALONG THE ARC OF SAID CURVE AND ALONG SAID PARALLEL LINE, HAVING A RADIUS OF 2627.62 FEET AND A CENTRAL ANGLE OF 02° 30'22", A DISTANCE OF 114.93 FEET; THENCE SOUTH 89° 31'10" WEST, ALONG SAID LINE 373 FEET NORTH OF AND PARALLEL WITH THE SOUTH LINE OF SECTION 32, A DISTANCE OF 18.93 FEET TO THE POINT OF BEGINNING.

SAID LANDS SITUATE IN THE CITY OF BOCA RATON, PALM BEACH COUNTY, FLORIDA, AND CONTAIN 3.949 ACRES, MORE OR LESS.

HAS CAUSED THE SAME TO BE SURVEYED, SUBDIVIDED AND PLATTED AS SHOWN HEREON, AND DOES HEREBY DEDICATE AND RESERVE AS FOLLOWS:

01. TRACT "B", AS SHOWN HEREON, IS HEREBY DEDICATED TO THE PUBLIC FOR RIGHT-OF-WAY PURPOSES.

02. THE LIMITED ACCESS EASEMENTS, AS SHOWN HEREON, ARE HEREBY DEDICATED TO THE CITY OF BOCA RATON, FLORIDA, FOR THE PURPOSE OF CONTROL AND JURISDICTION OVER ACCESS RIGHTS.

03. THE UTILITY EASEMENTS, AS SHOWN HEREON, ARE HEREBY DEDICATED IN PERPETUITY TO THE CITY OF BOCA RATON FOR THE INSTALLATION, CONSTRUCTION, RECONSTRUCTION, OPERATION, MAINTENANCE, AND REPAIR OF WATER, SEWER, AND DRAINAGE, TRAFFIC CONTROL, AND OTHER FACILITIES OF THE CITY, FACILITIES OF PUBLIC UTILITIES OPERATING PURSUANT TO A FRANCHISE OR OTHER GRANT OF APPROVAL FROM THE CITY, AND ANY AND ALL OTHER USES AUTHORIZED BY THE CITY TOGETHER WITH APPURTENANCES OVER, THROUGH AND ACROSS SAID EASEMENTS. SAID EASEMENTS SHALL ALSO BE EASEMENTS FOR THE CONSTRUCTION, INSTALLATION, MAINTENANCE, AND OPERATION OF CABLE TELEVISION SERVICES; PROVIDED, HOWEVER, NO SUCH CONSTRUCTION, INSTALLATION, MAINTENANCE AND OPERATION OF CABLE TELEVISION SERVICES SHALL INTERFERE WITH THE FACILITIES AND SERVICES OF AN ELECTRIC, TELEPHONE, GAS OR OTHER PUBLIC UTILITY. IN THE EVENT A CABLE TELEVISION COMPANY DAMAGES THE FACILITIES OF A PUBLIC UTILITY, IT SHALL BE SOLELY RESPONSIBLE FOR THE DAMAGES. THIS SECTION SHALL NOT APPLY TO THOSE PRIVATE EASEMENTS GRANTED TO OR OBTAINED BY A PARTICULAR ELECTRIC, TELEPHONE, GAS OR OTHER PUBLIC UTILITY. SUCH INSTALLATION, MAINTENANCE AND OPERATION SHALL COMPLY WITH THE NATIONAL ELECTRICAL SAFETY CODE AS ADOPTED BY THE FLORIDA PUBLIC SERVICE COMMISSION.

04. THE BUS STOP EASEMENT AS SHOWN HEREON IS HEREBY DEDICATED IN PERPETUITY TO THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, FOR THE CONSTRUCTION, INSTALLATION, MAINTENANCE, REPAIR, REMOVAL, RELOCATION. IMPROVEMENT, ACCESS AND USE OF A PUBLIC TRANSIT BUS SHELTER BOARDING AND ALIGHTING AREA. THE EASEMENT GRANTED HEREUNDER SHALL BE NON-EXCLUSIVE AND SUBORDINATE TO ANY PUBLIC UTILITY EASEMENT DEDICATED TO THE PUBLIC.
