

DESCRIPTION, DEDICATION AND RESERVATION.

KNOW ALL MEN BY THESE PRESENTS THAT NORTRAX EQUIPMENT COMPANY-SOUTHEAST, L.L.C., A DELAWARE LIMITED LIABILITY COMPANY, OWNER OF THE LAND SHOWN HEREON AS NORTRAX AT RIVIERA BEACH BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

A PARCEL OF LAND IN THE NORTHWEST 1/4 OF SECTION 31, TOWNSHIP 42 SOUTH, RANGE 43 EAST, PALM BEACH COUNTY, FLORIDA, DESCRIBED AS FOLLOWS:

COMMENCE AT THE NORTHWEST CORNER OF SAID SECTION 31; THENCE SO2°10'27"W, ALONG THE WEST LINE OF SAID SECTION 31, A DISTANCE OF 397.78 FEET TO A POINT OF INTERSECTION WITH THE WESTERLY RIGHT-OF-WAY LINE OF STATE ROAD NO. 9 (INTERSTATE NO. 95), WHICH POINT IS ALSO THE POINT OF BEGINNING OF THE PARCEL OF LAND HEREINAFTER TO BE DESCRIBED; THENCE CONTINUE SO2°10'27"W, ALONG SAID WEST LINE OF SECTION 31, A DISTANCE OF 1327.21 FEET TO A POINT ON THE NORTHEASTERLY RIGHT-OF-WAY LINE OF STATE ROAD NO. 710 (BEELINE HIGHWAY); THENCE S53°12'30"E, ALONG SAID NORTHEASTERLY RIGHT-OF-WAY LINE, A DISTANCE OF 775.73 FEET TO ITS INTERSECTION WITH THE WESTERLY RIGHT-OF-WAY LINE OF SAID STATE ROAD NO. 9 (I-95); THENCE FOR THE REMAINING 4 COURSES ALONG THE SAID WESTERLY RIGHT-OF-WAY LINE OF STATE ROAD NO. 9 (I-95) AS FOLLOWS: N19°20'02"W, A DISTANCE OF 135.06 FEET; THENCE N70°39'58"E, A DISTANCE OF 50.00 FEET TO A POINT; THENCE N19°20'02"W, A DISTANCE OF 1585.36 FEET TO A POINT OF CURVATURE; THENCE NORTHWESTERLY ON THE ARC OF A CIRCULAR CURVE, CONCAVE TO THE NORTHEAST, HAVING FOR ITS ELEMENTS A RADIUS OF 3014.93 FEET, A CENTRAL ANGLE OF 03°00'40" THROUGH AN ARC DISTANCE OF 158.43 FEET, RECORDED DISTANCE (158.45 MEASURED DISTANCE), TO THE POINT OF BEGINNING.


