

4) THE LAKE MAINTENANCE EASEMENTS (LME), AS SHOWN HEREON, ARE HEREBY RESERVED FOR JMC-IV REAL ESTATE COMPANY, A GEORGIA GENERAL PARTNERSHIP, LICENSED TO DO BUSINESS IN FLORIDA, AND MANHEIM REMARKETING, INC., A DELAWARE CORPORATION, LICENSED TO DO BUSINESS IN FLORIDA, THEIR SUCCESSORS AND ASSIGNS, FOR ACCESS TO STORMMATER MANAGEMENT AND DRAINAGE FACILITIES LOCATED WITHIN THE ASSOCIATED WATER MANAGEMENT TRACT FOR PURPOSES OF PERFORMING ANY AND ALL MAINTENANCE ACTIVITIES PURSUANT TO THE MAINTENANCE OBLIGATION OF SAID ENTITIES. 


