

SANDGLASS OF WESTLAKE - PHASE 1 A

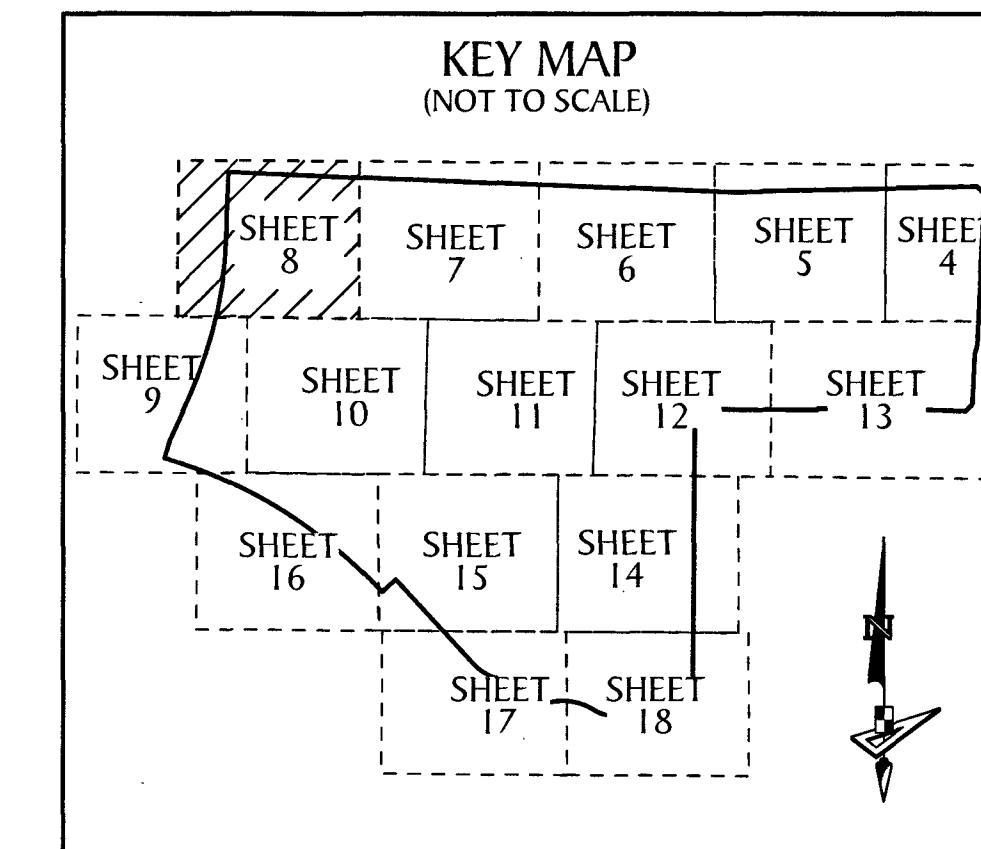
