tached plat as REPLAT OF PART OF BLOCKS 28, 29, 35, 36, 40,  
41 & 45, NEMAHIA, do hereby resubdivide the same into the fol  
lowing lots:

Beginning at the northeasterly corner of Lot 8, Block 28, at  
the intersection of the northwesterly line of Lot 8 and the  
southeasterly corner of Lot 9, Block 28, run thence  
northeastly along the northeasterly line of Lots 8 & 9, inclusive,  
and so continue to the southeasterly line of Park Row, all ac  
cording to the original survey of the east line of Section  
33, Township 41 South, Range 37 East; thence run  
along the southeasterly line of Park Row to the northeasterly line of  
Lot 1, Block 45, of said Nemahia, thence northeasterly along the  
southeasterly line of said Lot 1, Block 45, and the southwesterly  
line of Lot 1, Block 45, thence northeasterly along the southwesterly  
line of Lot 1, Block 45, thence northeasterly along the northwesterly  
line of Lots 1 and 2, Block 45, and so to the point of beginning.
