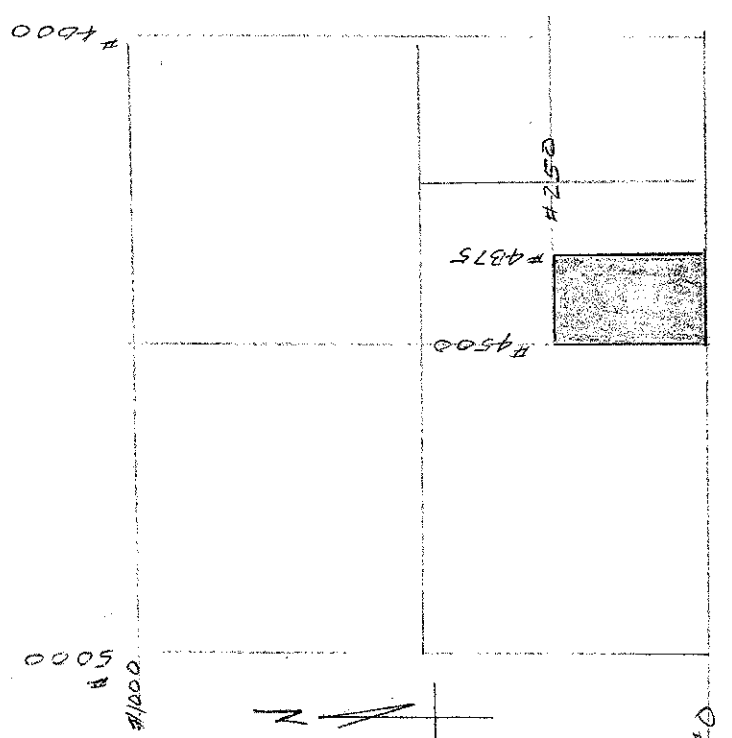

# HENRY'S MILITARY TRAIL ADD.

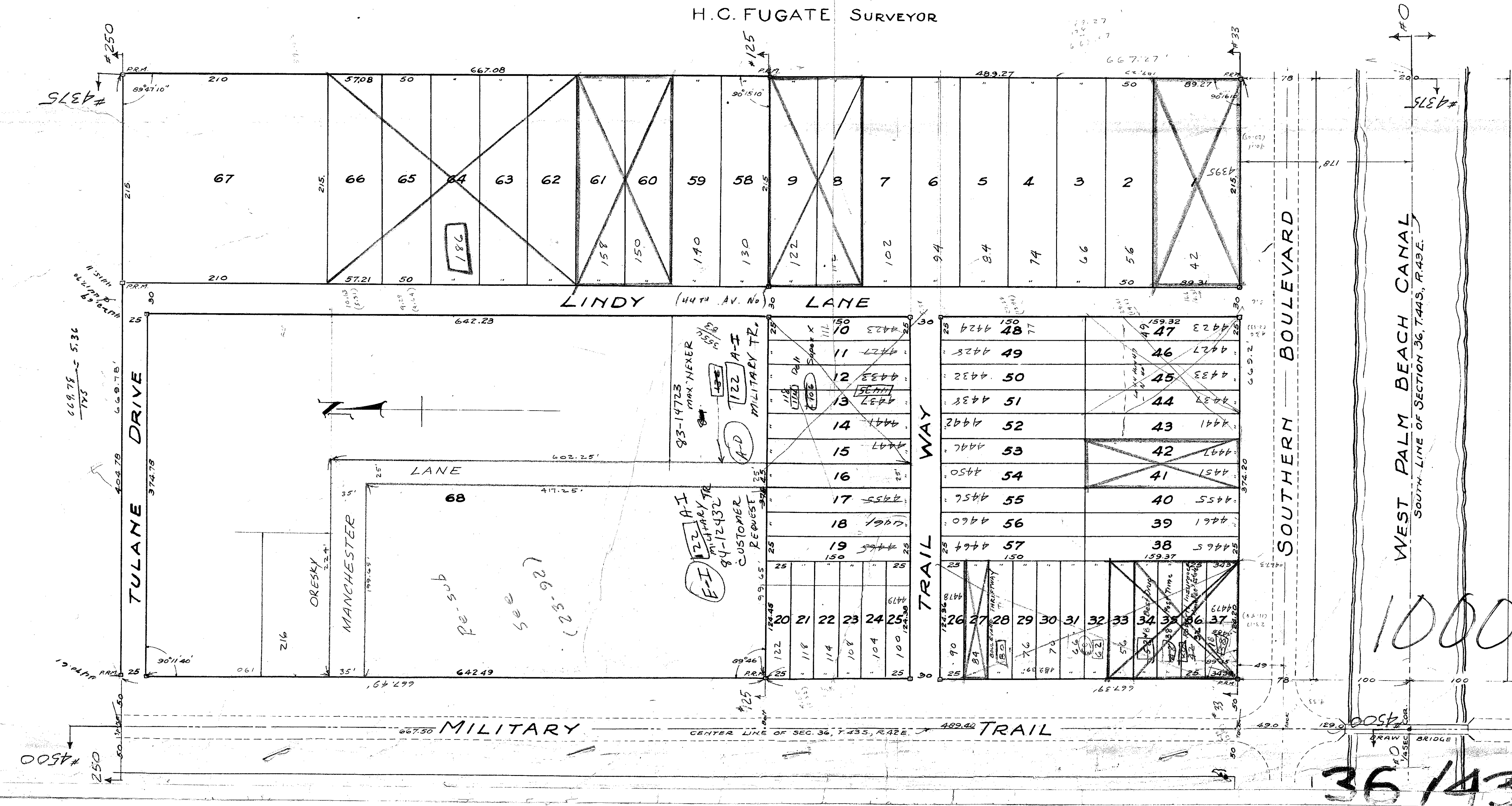
