

KNOW ALL MEN, BY THESE PRESENTS that Robert P. Sweetman and Loretta T. Sweetman, his wife, owners in fee simple of the tract of land shown hereon as "AMENDED PLAT OF TRADE WINDS ESTATES" which is to correct that certain Plat of "TRADE WINDS ESTATES" as filed in Plat Book 21, Page 45, and more particularly described as a Resubdivision of all that part of Gov. Lot 1 lying West of the W. 1/2 line of State Road 1 (Old Dixie Highway #1) except the N. 1/2, and all of Gov. Lot 2, East of the E. 1/2 line of F.E.C. R.R. and West of U.S. Highway #1, except that part thereof conveyed to A.T.T.Co. by deed dated June 7, 1946 and also all of the N. 1/2 of S.W. 1/4 of NE. 1/4 of Sec. 4, Twp. 46S. and West of U.S. Highway #1, except the S. 1/2 of the E. 1/2 line of F.E.C. R.R. and West of U.S. Highway #1, as shown hereon, all above described tracts being in Sec. 4, Twp. 46S., Rge. 43E., Palm Beach County, Florida, have caused the same to be surveyed and subdivided as shown hereon and do by these presents dedicate to the perpetual use of the public all the streets, highways and roads shown hereon, except those marked (PRIVATE) reserving unto themselves, their heirs, successors, assigns or legal representatives the reversion or reversions of the same whenever abandoned by the public or discontinued by law.
