

All Buildings set backs and other restrictions shall conform to Palm Beach County Zoning regulations or deed restrictions whichever shall be greater.  
There shall be no Buildings or other structures placed on Utility Easements.  
There shall be no Buildings or any kind of construction or trees or shrubs placed on Drainage Easements.  
All Curves at Street intersections are 25 foot radius unless otherwise shown; for convenience dimensions are shown at the intersection point.  
All Curve dimensions are arc.

BLOCK A, BERMUDA TERRACE SECTION 2 is hereby dedicated to each lot of BERMUDA TERRACE SECTION 2, for the use of the owner thereof with undivided interest subject to Drainage Easement, for the health and welfare of the community and for County maintenance of streets.
