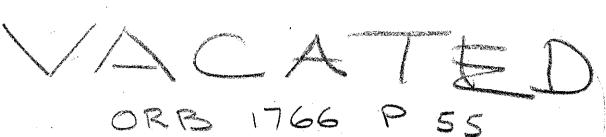

KNOW ALL MEN BY THESE PRESENTS, that HOMECO REALTY, INC., a Florida Corporation, the owner of the tract of land lying and being in Section 27, Township 43 South, Range 42 East, Palm Beach County, Florida, shown hereon as BELVEDERE COMMERCIAL AREA, and more particularly described as follows, to wit:

From the southeast corner of Section 27, Township 43 South, Range 42 East, Palm Beach County, Florida, run westerly along the south line of said Section 27, a distance of 150 feet to the Point of Beginning of the tract of land hereinafter described; thence continue westerly along the same course, a distance of 1027.55 feet; thence northerly at right angles to the preceding course, a distance of 234 feet to the beginning of a curve concave to the west having a radius of 3811.31 feet and a central angle of 3°27'35"; thence northerly along the arc of said curve, a distance of 230.14 feet to the end of said curve and a point in a line parallel to and 464 feet northerly from (measured at right angles to) the south line of said Section 27; thence easterly along said parallel line, a distance of 1032.88 feet to a point in the west line of Block 10, Plat No.1, Meadowbrook, according to the plat thereof recorded in Plat Book 26, Page 159; thence southerly along the westerly line of said Block 10 and its southerly extension, a distance of 464 feet to the Point of Beginning.
