KNOW ALL MEN BY THESE PRESENTS: That The Palm Beach Farms Company, a corporation of Colorado, owner in fee simple of certain lands situated in Palm Beach County, Florida, being parts of Sections 7 and 18 and all of Sections 2, 9, 17, 19, 20, the N^W 1/4 of Section 11, the N^E 1/4 of Section 18 and all of Sections 29 and 30 in Township 46 South, Range 47 East, has caused its said lands to be subdivided into tracts and roads as shown on this its PLAT NO. 1, the same being numbered and said roads marked as designated on said plat.

And said Company hereby certifies that said plat accurately represents its said lands, together with the subdivision thereof into tracts and roads and the correct position thereof relative to the corners of the United States Government survey, and hereby dedicates to the public the use of the said roads it being hereby expressly declared that each tract extends to the center line of the aforesaid strip of land sixteen rods wide, except the east tier of tracts in Section 9, the south tier of tracts in Section 9, the east tier of tracts in Section 17, the south tier of tracts in Sections 28, 29 and 30, the west tier of tracts in Sections 19 and 30 and the north tier of tracts in Sections 7, 8 and 9, wherein tracts extend to the adjoining section line, all of said aforesaid strips being subject to said easement.
