

# DEDICATION

STATE OF FLORIDA COUNTY OF PALM BEACH SS

KNOW ALL MEN BY THESE PRESENTS that H.A.S. LAND DEVELOPMENT, INC., A Florida Corporation, the owner of a Tract of Land lying and being in Sections 10 and 11, Township 44 South, Range 42 East, Palm Beach County, Florida, shown hereon as GARDEN CONDOMINIUM APARTMENTS, and being more particularly

A parcel of land in the East Half (E-1/2) of Section 10, and the West Half (W-1/2) of Section 11, Township 44 South, Range 42 East, Palm Beach County, Florida, and being more particularly described

That part of the West 358.36 feet of TRACTS 29 and 30, MODEL LAND COMPANY'S SUBDIVISION of the WEST HALF (W-1/2) of SECTION 11, Township 44 South, Range 42 East, as recorded in Plat Book 5, Page 76, Palm Beach County Public Records, lying North of the North Right-of-Way line of Forest Hill Boulevard, AND that part of the East 40 feet of the Southeast Quarter (SE-1/4) of Section 10, Township 44 South, Range 42 East, lying North of the North Right-of-Way line of Forest Hill Boulevard, and being more particularly described as follows:

Commencing at the Southwest corner of Section 11, Township 44 South, Range 42 East; thence run on an assumed bearing of due North along the West line of Section 11 and centerline of Sherwood Forest Boulevard, a distance of 1333.59 feet to a point; said point being the intersection of the centerline of Sherwood Forest Boulevard and Forest Hill Boulevard, as now laid out and in use; thence run N89°57'15"E along the centerline of Forest Hill Boulevard, a distance of 383.36 feet to a point; thence run due North a distance of 60.00 feet to a point on the ultimate North right-of-way line of Forest Hill Boulevard and the POINT OF BEGINNING of the herein described parcel of land; thence run S89°57'15"W along the said ultimate North right-of-way line of Forest Hill Boulevard, a distance of 423.36 feet to a point; thence run due North a distance of 1238.12 feet to a point on the South right-of-way line of L.W.D.D. Canal No. L-7; thence run due East along said South right-of-way line a distance of 423.36 feet to a point; thence run due South along the West Property line of Forest Manor, as recorded in Plat Book 28, Page 17, Public Records of Palm Beach County, Florida, a distance of 1237.78 feet to the Point of Beginning.


