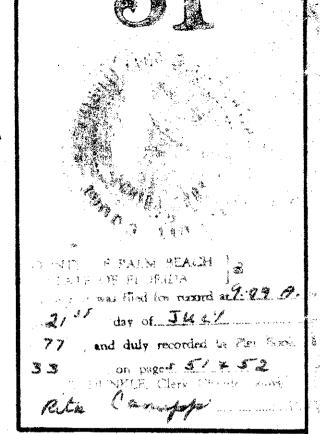

DEDICATION

KNOW ALL MEN BY THESE PRESENTS: that CAMINO REAL INVESTMENTS, LIMITED, a limited Partnership, owners of the land shown hereon, being the Southeast quarter of the Southeast quarter of the Northeast quarter (5E½ of 5E½ of NE½) and the East half of the Southwest quarter of the Southeast quarter of the Northeast quarter (E½ of 5W¼ of 5E¼ of NE¼) of Section 28, Township 47 South, Range 42 East; less the South 40 feet for canal right-of-way, less the East 53 feet for Public road right-of-way, and subject to F.P.L. easement, being in Palm Beach County, shown hereon as CAMINO REAL CENTRE being more fully described as follows:

Commence at the Southeast corner of the Northeast quarter of Section 28, Township 47 South Range 42 East, Palm Beach County, Florida; thence \$89°20'42"W, along the Southerly boundary of the North one-half of said Section 28, 53.00 feet to a point on the Westerly right-of-way of Powerline Road; thence N 01°03'02"W along the Westerly right-of-way of Powerline Road, 15.00 feet to the Point of Beginning of the herein described parcel, said P.O.B. being on the Northerly right-of-way of Lake Worth Drainage District Canal L-49; thence \$89°20'42"W along the Northerly right-of-way of aforesaid Canal L-49, 941.75 feet to a point on the Easterly boundary of Tract 18, P.U.D. Boca Del Mar No. 6 as recorded in Plat Book 30, Pages 142 and 143 of the Palm Beach County Public Records; thence N 00°57'37"W, along the Easterly boundary of aforesaid Tract 18, 651.57 feet to a point being the Southwest corner of Tract 18-A, of aforesaid P.U.D. Boca Del Mar No.6; thence N 89°28'02"E along the Southerly boundary of aforesaid Tract 18-A, 940.73 feet to a point on the Westerly right-of-way of Powerline Road; thence S 01°03'02"E along the Westerly right-of-way of Powerline Road, 649.57 feet to the Point of Beginning.

Less the following described parcel: Commerce at the Southeast corner of said Northeast quarter; thence "NOI"03'02" W, along the centerline of Powerline Road, also being the East line of said Section 28, 664.46 feet to a point; thence run 589° 28'02" W, 53.00 feet to a point on the existing right-of-way line of Powerline Road, being the Point of Beginning; thence 501°03'02" E, 200.90 feet to a point; thence 589° 28'02" W, 210.38 feet to the point of curvature of a curve to the right, having a radius of 25.00 feet; thence run along said curve thru a central angle of 89° 28'56" an arc distance of 39.04 feet to the point of tangency; thence run N 01° 03'02" W, 176.12 feet to a point; thence run N 89° 28'02" E, 235.16 feet to the Point of Beginning.
