RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, ABANDONING PLATTED RIGHTS OF WAY KNOWN AS ERICA COURT AND CORDOBA LANE AS SHOWN ON THE PLAT OF BOCA AZUL, PHASE ONE RECORDED IN PLAT BOOK 41, PAGES 191 AND 192, OF THE PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA.

All of Erica Court, as shown on the Plat of Boca Azul, Phase One, together with, all of Cordoba Lane, lying East of the East right of way of Lyons Road; said right of way line being defined as being 29.00 feet East of, and parallel to, the West boundary of the Plat of Boca Azul - Phase One, according to the Plat thereof, as recorded in Plat Book 41, Pages 191 and 192 of the Public Records of Palm Beach County, Florida.

3. Notice of the adoption of this resolution shall be published once in the Palm Beach Post/Times within thirty (30) days of the date of adoption of this resolution in accordance with Section 336.10, Florida Statutes, and Ordinance No. 71-3.
