- 12. PARCEL 6 IS HEREBY DEDICATED TO THE PALM BEACH PARK OF COMMERCE ASSOCIATION AS A UTILITIES SITE AND FOR OTHER PROPER AND SUITABLE PURPOSES. WITHOUT RECOURSE TO PALM BEACH COUNTY.
- 13. THE LIFT STATION EASEMENTS AS SHOWN HEREON ARE DEDICATED IN PERPETUITY TO THE PALM BEACH PARK OF COMMERCE ASSOCIATION INC. ITS SUCCESSORS AND ASSIGNS FOR LIFT STATIONS AND RELATED PUPPOSES.
- 14. PALM BEACH COUNTY SHALL HAVE THE RIGHT, BUT NOT THE OBLIGATION, TO MAINTAIN THAT PORTION OF THE DRAINAGE SYSTEM, ENCOMPASSED BY THIS PLAT, WHICH IS ASSOCIATED WITH THE BRAINAGE OF PUBLIC ROADS.
