UTILITY EASEMENTS, AS SHOWN HEREON, RE HEREBY DEDICATED IN PERPETUITY FOR THE CONSTRUCTION AND MAINTENANCE OF UTILITY FACILITIES.

Drainage Easements, as shown hereon, are hereby dedicated to Lantana Homes Homeowners Association, Inc., Is successors, and/or assigns FOR THE CONSTRUCTION AND MAINTENANCE OF DRAINAGE AND IS THE PERPETUAL MAINTENANCE OBLIGATION OF SAID ASSOCATION WITHOUT RECOURSE TO PALM BEACH COUNTY. 

VICINITY MAP NOT TO SCALE




