Commence at the Northeast corner of Section 18, Township 46 South, Range 43 East; thence run South 00°29'01" East along the East line of said Section 18, 40.03 feet to a point in the South right-of-way line of Lake Worth Drainage District Canal E-4; thence run North 88°24'49" West, along said South line 681.93 feet to the Point of Beginning of the herein described parcel; thence from a tangent bearing South 18°40'08" West run Southwesterly along a curve concave to the Southeast having a radius of 3,214.93 feet thru an angle of 08°54′30″, an arc distance of 499.86 feet to a point; thence North 80°36'16" West, 137.25 feet to a point of curve of a curve concave to the Southwest, having a radius of 336.86 feet; thence run Southwesterly along said curve thru an angle of 12°35'28", an arc distance of 74.03 feet to a point; thence North 12°12'34" East, 220.07 feet to a point; North 77°47'26" West, 222.88 feet to a point on the Easterly right-of-way of Congress Avenue; thence from a tangent bearing North 13°15′13″ East, run along said Easterly line, with a curve concave to the Southeast having a radius of 3759.80 feet thru an angle of 03°16'41", an arc distance of 215.11 feet to a point in the aforementioned South right-of-way line of Canal E-4; thence run South 88°24'49" East along said South line 447.98 feet to the Point of Beginning. 
