ALL DRAINAGE EASEMENTS, AS SHOWN HEREON, ARE HEREBY DEDICATED IN PERPETUITY FOR THE CONSTRUCTION, OPERATION, AND MAINTENANCE OF DRAINAGE FACILITIES AND ARE THE PERPETUAL MAINTENANCE OBLIGATION OF THE P.G.A. NATIONAL COMMERCE PARK ASSOCIATION, INC. WITHOUT RECOURSE TO THE NORTHERN PALM BEACH COUNTY IMPROVEMENT DISTRICT NO STRUCTURES, TREES, OR SHRUBS SHALL BE LOCATED WITHIN SAID EASEMENTS. WHERE DRAINAGE AND UTILTY EASEMENTS CROSS, DRAINAGE SHALL TAKE PRECEDENCE.


