INCLUSIVE, IS HEREBY DEDICATED TO THE NORTHERN PALM BEACH COUNTY IMPROVEMENT DISTRICT AND THE TOWN OF JUPITER, THEIR SUCCESSORS AND ASSIGNS, TOGETHER WITH AN EASEMENT, BUT NOT THE OBLIGATION, OVER, UNDER, UPON AND THROUGH SAID TRACTS R1 THROUGH R54, INCLUSIVE. TO CONSTRUCT, OPERATE AND MAINTAIN ROADS, UTILITIES OR ANY OTHER MODERN ROADWAY SYSTEM IMPROVEMENT, INCLUDING APPURTENANCES RELATED THERETO, DEEMED APPROPRIATE BY THE NORTHERN PALM BEACH COUNTY IMPROVEMENT DISTRICT OR THE TOWN OF JUPITER.

7. THE WATER MANAGEMENT EASEMENTS, AS SHOWN HEREON, ARE HEREBY DEDICATED TO THE NORTHERN PALM BEACH COUNTY IMPROVEMENT DISTRICT, ITS SUCCESSORS AND ASSIGNS, FOR THE CONSTRUCTION, OPERATION AND MAINTENANCE OF WATER MANAGEMENT FACILITIES, THE LANDS THEREIN AND THEREUNDER BEING THE PERPETUAL MAINTENANCE OBLIGATION OF SAID DISTRICT, ITS SUCCESSORS AND ASSIGNS, WITHOUT RECOURSE TO PALM BEACH COUNTY OR THE TOWN OF JUPITER. SAID DISTRICT SHALL HAVE THE RIGHT TO CONSTRUCT, OPERATE, AND MAINTAIN WATER MANAGEMENT FACILITIES WITHIN THESE EASEMENTS. THERE SHALL BE NO BUILDINGS, STRUCTURES, CONSTRUCTION OF ANY KIND, TREES OR SHRUBS, ETC. PLACED ON OR INSTALLATION OF UTILITIES OR EXCAVATION ON SUCH EASEMENTS DEDICATED TO THE NORTHERN PALM BEACH COUNTY IMPROVEMENT DISTRICT, AS SHOWN HEREON, UNLESS APPROVED,

8. TRACT A, AS SHOWN HEREON, IS HEREBY DEDICATED TO PALM BEACH COUNTY SUBJECT TO THE TERMS AND CONDITIONS OF THE CONSERVATION EASEMENT AS RECORDED IN OFFICIAL RECORD BOOK 9567, PAGES 793 THROUGH 831 INCLUSIVE AS AMENDED FROM TIME TO TIME BY PARTIES THERETO. OF THE PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA AND SUBJECT TO A LANDSCAPE AND DRAINAGE EASEMENT AND OTHER EASEMENTS SHOWN HEREON HEREBY DEDICATED TO THE NORTHERN PALM BEACH COUNTY IMPROVEMENT DISTRICT OVER SAID TRACT A.

9. THE TEN FOOT SIDEWALK EASEMENT AS SHOWN HEREON IN TRACTS CC2, GW6, GW11, RN6B1, RN6B2, WK2, WK3, R49, R55 AND R56 IS HEREBY DEDICATED TO PALM BEACH COUNTY FOR PEDESTRIAN INGRESS/EGRESS WITHOUT RECOURSE TO THE NORTHERN PALM BEACH COUNTY IMPROVEMENT DISTRICT: SAID EASEMENT WILL AUTOMATICALLY BE DEEMED RELEASED FROM THE TERMS AND CONDITIONS OF THIS PLAT AS TO ANY PORTION OF SAID PROPERTY DEEDED BY PUBLIC RECORD TO PALM BEACH COUNTY AND SUCH RELEASED PROPERTY SHALL THEREAFTER NOT BE SUBJECT TO OR ENCUMBERED BY SAID SIDEWALK EASEMENT.

ALL OF TRACT B (CENTRAL BOULEVARD), TRACT C (FREDRICK SMALL ROAD), TRACTS R55, R56. R57, R58 AND R59, AS SHOWN HEREON, ARE HEREBY DEDICATED TO PALM BEACH COUNTY FOR ROADWAY AND OTHER PROPER PURPOSES SUBJECT TO EASEMENTS SHOWN HEREON.

IN PERMIT FORM, BY THE SAID DISTRICT.

THE WATER MANAGEMENT MAINTENANCE EASEMENTS, SHOWN HEREON AS W.M.M.E., ARE HEREBY DEDICATED TO THE NORTHERN PALM BEACH COUNTY IMPROVEMENT DISTRICT, ITS SUCCESSORS AND ASSIGNS, FOR ACCESS TO STORMWATER MANAGEMENT FACILITIES LOCATED WITHIN THE ADJACENT GREENWAY TRACTS FOR PURPOSES OF PERFORMING ANY AND ALL MAINTENANCE ACTIVITIES PURSUANT TO THE MAINTENANCE OBLIGATION OF SAID DISTRICT, ITS SUCCESSORS AND ASSIGNS, WITHOUT RECOURSE TO THE TOWN OF JUPITER. THE MAINTENANCE OF SAID EASEMENTS SHALL BE THE PERPETUAL RESPONSIBILITY OF THE RESPECTIVE

THE WILDLIFE ACCESS EASEMENT SHOWN HEREON IS HEREBY GRANTED TO THE NORTHERN PALM BEACH COUNTY IMPROVEMENT DISTRICT, ITS SUCCESSORS AND ASSIGNS, FOR THE CONSTRUCTION, OPERATION AND MAINTENANCE OF A GOPHER TORTOISE CROSSING AND IS THE PERPETUAL MAINTENANCE OBLIGATION OF SAID DISTRICT, ITS SUCCESSORS AND ASSIGNS, WITHOUT RECOURSE TO PALM BEACH COUNTY OR THE TOWN OF JUPITER.
