SUBJECT TO EXISTING EASEMENTS, RIGHTS-OF-WAY, RESERVATIONS AND RESTRICTIONS, OF RECORD, IF ANY.

Have caused the same to be surveyed and platted as shown hereon and do hereby dedicate as follows:

Tract R, as shown hereon, is hereby reserved to Crystal Key at Woolbright Place Homeowners Association Inc., a Florida corporation, not for profit, its successors and assigns, as a private roadway for ingress, egress, utilities, drainage and other purposes not inconsistent with this reservation, and is the perpetual maintenance obligation of said Association, its successors and assigns, without recourse to the City of Boynton Beach, Florida.

Tract B, as shown hereon, is hereby reserved to Crystal Key at Woolbright Place Homeowners Association Inc., a Florida corporation, not for profit, its successors and assigns, for open space purposes and is the perpetual maintenance obligation of said Association, its successors and assigns, without recourse to the City of Boynton Beach, Florida.

Tract C, as shown hereon, is hereby reserved to Crystal Key at Woolbright Place Homeowners Association Inc., a Florida corporation, not for profit, its successors and assigns, for recreational purposes and is the perpetual maintenance obligation of said Association, its successors and assigns, without recourse to the City of Boynton Beach, Florida.

The City of Boynton Beach shall have the right, but not the obligation, to maintain any portion of the drainage system encompassed by this plat which is associated with the drainage of public streets, including the right to utilize for proper purposes any and all drainage, lake maintenance, and lake maintenance access easements associated with said drainage system.

The utility easements as shown hereon are hereby dedicated in perpetuity for the construction and maintenance of utility facilities, including cable television systems. The installation of cable television sytems shall not interfere with the construction and maintenance of other utilities.

The limited access easements as shown hereon are hereby dedicated to the City of Boynton Beach, for the purpose of control and jurisdiction over access rights.

This plat is subject to Woolbright Place Master Association Declaration of Protective Covenants (O.R.B. 8649, Pg. 968, P.B.C.R.)

The buffer easements as shown hereon are hereby reserved for the Crystal Key at Woolbright Place Homeowners Association Inc., a Florida corporation, not for profit, its successors and assigns, for landscape buffer purposes and is the perpetual maintenance obligation of said Association, its successors and assigns, without recourse to the City of Boynton Beach, Florida.




