IMPORTANT INFORMATION

Applicants exempt from titling, pursuant to Section 328.01, F.S., should complete the reverse side of this form and provide the following applicable documentation and pay the appropriate taxes and fees.

OUT OF STATE REGISTRATIONS

Must provide a copy of out-of-state registration which is in full force and effect.

DEALER REGISTRATION

Applicant must provide a copy of current sales tax certificate of registration assigned by the Department of Revenue and a copy of current commercial or occupational business license, if such a license is required by the local government entity in which the manufacturer or dealer operates a vessel.

DOCUMENTED VESSEL

Copy of Marine document papers or a completed Documented Certification, HSMV 87135 and sales tax, as applicable.

GOVERNMENT VESSEL

Proof of ownership i.e. Manufacturers Statement of Origin, Court Order, Previous title signed over to agency.

AMPHIBIOUS VESSEL

Copy of vehicle certificate of title issued by the Department.

DEFINITION OF RESIDENT AND ALIEN:

A "Resident" is any citizen of the United States who has continuously resided in Florida for one year and in a given county for six months immediately preceding the making of this application.

An "Alien" is a person who is not a citizen of the United States, although such a person may reside in Florida..

SIGNATURE REQUIREMENT FOR CO-OWNERS AND FIRMS

All persons claiming an interest in the vessel being registered are required to sign the application for registration.

ELECTION CAMPAIGN FINANCING TRUST FUND

Florida law allows for a voluntary contribution of \$5 per taxpayer for the purpose of providing for public financing of political campaigns for the offices of Governor and member of the Cabinet.

Section 837.06, Florida Statutes, provides that whoever knowingly makes a false statement in writing with intent to mislead a public servant in the performance of his official duty shall be guilty of a misdemeanor of the second degree, punishable as provided in ss. 775.082, 083, and 084, F.S.
